## AM ORDINANCE OF AMEXATION

THE CITY COUNCIL OF THE CITY OF TRACY, MINNESOTA, DO ORDAIN:
SECTION 1. That the City of Tracy, Minnesota, is the owner
of the following described tracts or parcels of land lying and being
in the County of Lyon and State of Minnesota, described as follows,
