## INTRODUCTION OF BILLS.

No. 356, A bill for an act amending and supplementing Chapter 461, Laws 1921 (as amended by Chapter 418, Laws 1923, as amended by Chapter 299, Laws 1925) by inserting therein a new section numbered 13A, reciprocally permitting citizens of adjoining states and of adjoining Canadian provinces actually residing within twenty-five miles of the Minnesota state line to operate their motor vehicles tax free upon the streets and highways of this state within a limited zone and under certain conditions prescribed by this act, if and when like privileges
