Whereas, He represented the fourteenth Legislative District in the House and was one of its most beloved members; and

Whereas, In a long and useful life in the Community of Redwood Falls and the County of Redwood, he has served the people as County Commissioner, as mayor, as Chairman of the Board of Education, and in many other capacities, always giving his wholehearted efforts in the interest of public service; and

Whereas, During his service in the House, he was a man of broad human sympathies, and a true friend of the common man, whom he represented ably and well;

Now, Therefore, Be It Resolved by the House of Representatives of the State of Minnesota that we hereby declare our sense of loss at his death, and extend our sincere sympathy to his bereaved family and that the Chief Clerk send an engrossed copy of this Resolution to the family as a mark of our esteem and affection for our departed colleague; and

Be It Further Resolved, That the Speaker of the House of Representatives be and he is hereby directed to appoint a Committee of the House to attend the funeral, to forward our floral tribute and make all other arrangements suitable for proper observance and respect to the memory of our late and highly esteemed fellow member, Hans M. Aune, and that we, the members of the House of Representatives of the State of Minnesota in session now duly assembled, do now pause momentarily in silent and reverent respect to our departed friend and fellow member.
