HONORABLE MARTIN J. CONROY.

To the Honorable State Senate of the State of Minnesota:

Your committee appointed for the purpose of preparing a memorial commemorative of our colleague, the late Honorable Martin I. Conrov of Ramsey County, Senator from the Forty-first District, respectfully submits the following:

MARTIN J. CONROY was born in Ireland in the year 1881, and came to St. Paul with his parents in the spring of 1882. He received his education at St. John's Parochial School, and shortly afterwards entered the plumbing business. In 1903, he was appointed Chief Plumbing Inspector of the City of St. Paul, and served in that capacity for twelve years. In 1910, he was elected Vice President of the United Association of Plumbers, Steam Fitters and Sprinkling Fitters of the United States and Canada, which position he held until the time of his death. He was also business agent of the Plumbers' Union in St. Paul. Besides other offices in labor organizations, he served two terms as national president of the Sanitary Engineers. At the time of his death he was serving his second term as a member of the State Senate. He was unmarried. Senator Conroy because of his geniality and kindliness held the esteem and friendship of all of the members of the Senate during his service therein, and in his death his community and the Senate lost a good citizen and a loyal friend.
