Be It Resolved, That on or before the first day of February, 1919, the State Auditor be and he is hereby required to prepare and furnish for the use of the Committee on Appropriations, and also for distribution among the several departments a correct exhibit of all funds appropriated either generally or specifically, or actually available for the maintenance of each of said departments or which have otherwise been available thereto during each and all of the preceding Legislatures during the years 1901 to 1918, inclusive, and separately an exhibit of any unexpended or unused funds available to each of the said departments which have hitherto and in any way been appropriated or otherwise received and available thereto within the time stated.

Further, Be It Resolved, That two thousand (2,000) copies of said report required in section two (2) of this resolution be printed by the Chief Clerk, as soon as may be, for the use and benefit of the membership of this House and of the citizens of the state who may be enough interested to apply to the State Auditor for copies of the same.

Which was adopted.

Messrs. Howard and Brophey offered the following resolution-

Whereas, on Monday, January 13, 1919, there died in the city of Minneapolis, a distinguished member of the Minnesota Legislature; the Honorable Carleton L. Wallace, a man widely esteemed both as a public servant and a private citizen, and

Whereas, we, as personal friends and legislative associates, desire to place on record our estimate of his worth and ability.

Now, Therefore, be it resolved, by the House of Representatives of the Minnesota Legislature, that we, through this means, give expression to our appreciation of his admirable character and to our sorrow at the loss his family, his friends, and the public have sustained by reason of his untimely death.

Carleton L. Wallace was born at Saratoga Springs, New York, on June 10th, 1865. He lived in the City of Minneapolis continuously for nearly half a century, having moved to the city in 1871.

He graduated from the law department of the State University in 1897 and was elected to the Minnesota House of Representatives

He served as a member of the House in the 1899, 1901, 1902, 1905 and 1909 sessions and was elected a member of the Senate in 1910, and was re-elected a member of that body at each succeeding election, including that of 1918, and was just entering upon his fourth term as a Senator when his death occurred.

He was an untiring worker. A man of ability, high honor, and integrity, a scholar and a statesman.

Resolved further, that these resolutions be printed in the Journal of the House and that the Chief Clerk transmit a copy thereof to the family of the deceased.

Which was adopted by a unanimous rising vote.
