

Which was read for the first time and referred to the Committee on General Legislation.

Mr. McNulty introduced—

H. F. No. 200, A bill for an act relating to street railways, repealing Mason's Minnesota Statutes 1927, Sections 4816 to 4830, both inclusive, and re-enacting all acts or parts of acts conflicting with the provisions of said Mason's Minnesota Statutes 1927, Sections 4816 to 4830, both inclusive.

Which was read for the first time and referred to the Committee on General Legislation.

Messrs. Olson, Hanson, Johnson, A. I., Daun and Clark introduced—

H. F. No. 201, A bill for an act relating to chattel mortgages and conditional sales contracts and satisfaction thereof.

Which was read for the first time and referred to the Committee on Judiciary.

Messrs. Dickinson and Chilgren introduced—

H. F. No. 202, A bill for an act relating to land forfeited to the state for taxes, and legalizing sales of tax-forfeited lands heretofore made, and amending Mason's Supplement 1940, Section 2139-15, Subsection (g), as amended by Laws 1941, Chapter 511, Section 1, Subsection (g).

Which was read for the first time and referred to the Committee on Judiciary.

Mr. Bondhus introduced—

H. F. No. 203, A bill for an act to amend Mason's Minnesota Statutes of 1927, Section 162 as amended by Laws 1933, Chapter 22, relating to the time of holding court in the 13th Judicial District.

Which was read for the first time and referred to the Committee on Judiciary.

Messrs. Boehlke and Peterson, P. J. E., introduced—

H. F. No. 204, A bill for an act relating to the taxation of royalties for permission to explore, mine, take out and remove ore; amending Mason's Supplement 1940, Sections 2392-1 and 2392-1a.

Which was read for the first time and referred to the Committee on Taxes.

Messrs. Boehlke and Peterson, P. J. E., introduced—

H. F. No. 205, A bill for an act relating to the Occupation Tax upon the business of mining or producing iron ore or other ores; providing for the disposition of the proceeds of said tax; and appropriating a portion of the proceeds thereof for the purpose of developing the resources and rehabilitating the residents of certain counties; amending Mason's Supplement 1940, Sections 2373, 2373-1 and 2373-2.

Which was read for the first time and referred to the Committee on Taxes.

Messrs. Moore, Peterson, E., Wanvick and Vukelich introduced—

H. F. No. 206, A bill for an act relating to county levies for school purposes in certain counties, and to amend Laws 1921, Chapter 357,

Sections 2, 3 and 4, as amended by Laws 1941, Chapter 363.

Which was read for the first time and referred to the Committee on Towns and Counties.

Messrs. Egan, Miller and Ottinger introduced—

H. F. No. 207, A bill for an act relating to tax levies for general revenue funds in certain counties.

Which was read for the first time and referred to the Committee on Towns and Counties.

Mrs. Paige introduced—

H. F. No. 208, A bill for an act relating to housing for persons in need, providing for the leasing of new or remodeled dwelling quarters for such persons by the state, authorizing the sale of tax-forfeited land for the construction of such quarters, providing for the removal of buildings when necessary for the construction or protection of such quarters and for public health, safety, and welfare, appropriating money for the purposes of this act, and providing for the issuance of certificates of indebtedness and the making of tax levies to raise funds therefor.

Which was read for the first time and referred to the Committee on Welfare.

Messrs. Faimon and Connors introduced—

H. F. No. 209, A bill for an act relating to the loans of \$300.00 or less, amending Mason's Supplement 1940, Section 7774-57.

Which was read for the first time and referred to the Committee on Welfare.

Mr. Faimon introduced—

H. F. No. 210, A bill for an act relating to loans not to exceed \$300.00 in amount; amending Mason's Supplement 1940, Section 7774-53.

Which was read for the first time and referred to the Committee on Welfare.

Mr. Miller introduced—

H. F. No. 211, A bill for an act relating to tax levy for revenue purposes in certain counties; and providing for such tax levies to be in excess of present limitations.

Which was read for the first time and referred to the Committee on Towns and Counties.
