HOUSE RESOLUTION NO. 9.

A resolution commending the President of the United States for appointing Commander Harold E. Stassen as a member of the United States delegation to the United Nations peace conference.

Whereas, The Allied Powers in conference assembled have seen fit to institute a United Nations Conference to be held at San Francisco beginning April 25, 1945, for the purpose of formulating an international peace organization, and

Whereas, the agreements to be reached at this meeting will lay foundations for a new World Order for which all peoples of good will may work together without fear of an aggressor, and

Whereas, Harold E. Stassen, former Governor of Minnesota and now Commander Harold E. Stassen, in his political activities even prior to the present world crisis, demonstrated a thorough understanding of world problems and formulated a world plan which has been recognized as showing an exceptional grasp of international problems and manifesting a high degree of statesmanship;

Now, Therefore, Be It Resolved, that the House of Representatives of the State of Minnesota, in regular session assembled, on this 14th day of February 1945, hereby commend the President of the United States, Franklin D. Roosevelt, for his choice of Commander Harold E. Stassen as a member of the United States Delegation at such United Nations Peace Conference.

Be It Further Resolved, that the Chief Clerk be instructed to send engrossed copies of this Resolution to President Roosevelt and Commander Stassen.
