Counsel to Minnesota State Dental Association, Minnesota Food Retailers, United Federal Savings and Loan Association, Municipal Finance Council. He remained with the firm until his retirement in 1995. The LeVander, Gillen, and Miller law firm produced 2 Governors, a US Congressman, a US Senator and several MN Supreme Court justices.
