

Messrs. Krost, Stockwell and Champlin introduced—

Which was read for the first time and referred to the Committee on Rules.

GENERAL ORDERS.

After some time spent therein, the Committee arose and the Speaker resumed the chair, whereupon Mr. Thielen reported that the Committee had considered:

H. F. No. 25, which it recommended to pass as amended as follows:

In line 8, of Section 30, page 21, after the word "age" and before the "period" immediately following, insert the following language "residing therein".

In the first line of Section 7, subsection (f) page 8, after the word "obligations" and before the word "of" insert the words "heretofore issued".

Mr. Thielen moved the adoption of the report of the Committee of the Whole.

Mr. Bellman moved to amend the report of the Committee of the Whole by striking therefrom the words "which it recommended to pass as amended" and insert in lieu thereof the words "advanced to the Calendar as amended, subject to amendment".

Which motion prevailed and the report of the Committee of the Whole was amended.

The question then recurred on motion of Mr. Thielen that the report of the Committee of the Whole, as amended, be adopted.

Whereas, During his long and distinguished service as a member of the House he occupied the responsible positions and gave of his time, energy and ability in an unselfish manner;

Now, Therefore, Be It Resolved, By the House of Representatives of the State of Minnesota that we hereby declare our sense of loss at his death and extend our deepest sympathy to his bereaved family and that a copy of the resolution be sent to the family as a mark of our esteem and as a token of affection for the departed comrade and friend, and

Be It Further Resolved, That the Chief Clerk be and hereby is instructed to send a copy of this resolution to the family of the deceased.
