COLEMAN TO GET HILBERT'S PLACE

Will Be Named to Board of Control Vacancy Caused by Death

The body of Dr. P. A. Hilbert, democrat member of the state board of control, who died suddenly late yesterday, will be in state in the rotunda of the state capitol from 2 to 4 p. m. Sunday, it was announced today. The funeral services and burial will be at Minnieska, Minn., at 2 o'clock Monday.

At the same time it became unofflcially known at the capitol that John Coleman, superintendent of the Anoka state hospital for the insane since 1901, would be appointed by Governor Preus to succeed Dr. Hilbert.

Surviving the latter are two sisters, Mrs. Adalph Drenkhahn and Mrs. V. Preston, both of Minnieska, his wife and two daughters, Irene, now attending St. Catherine's college, and Marguerite, who is in school at Melrose.

Officials to Attend Funeral

Governor Preus and a large delegation of state officials including all control board members will attend the funeral, and the flag over the capitol will be half-masted while the service is going on.

Among the honorary pall-bearers will be the governor, Ralph Wheelock and C. J. Swenson of the board of control, Mr. Coleman, Julius Coller of Shakopee, F. M. Prince of First National bank, Minneapolis, Drs. L. B. Baldwin of St. Paul and Arthur Hamilton of Minneapolis and the following of

state senators, who were colleagues of Dr. Hilbert in the senate: Fred D. Vibert, E. J. Westlake, John D. Sullivan, George H. Sullivan, A. J. Rockne, Frank E. Putnam, and Peter E. Van Hoven.

The funeral train for Minnieska will leave Minneapolis at 8 a. m. and St. Paul at 8:50.

The tentative appointment of Mr. Coleman was made known to stop the flood of applications for the place which have swamped Governor Preus and Charles R. Adams, his private secretary, since the news of the death of Dr. Hilbert went abroad yesterday.

Mr. Coleman was appointed head of the Anoka institution by Governor John Lind. Before that time he was a member of the state board of charities and correction, which had control of state institutions before the board of control was created. He is running the Anoka institution more economically than any other state institution, it was said, and this was the main reason for his selection.

Appointed by Burnquist

Dr. Hilbert had been in the best of health. Thursday, however, he became ill and was taken to the Miller hospital, where death followed late yesterday.

He was the democrat member of the board. He was appointed July 1, 1920, by governor Burnquist, his term to expire April 7, 1921. It was his place a Governor Preus promised to fill by a swoman member last fall, and it was at the governor's desire to retain him to which led to the passage of the law providing for two women on the board.
