#### COMMEMORATING OLE LAGERSEN. ←

Ole Lagersen was born in Norway 63 years ago. He came to the United States in 1881 and for many years lived and made his home in the County of Anoka, Minnesota, where he died on the twentieth of March, 1929. He was a well known farmer of his district, a specialist in raising Jersey cattle and active in all public and co-operative movements. He held many public offices and was a member of this Legislature during the sessions of 1919 and 1921, during which time he took an active part in all progressive legislation.

In public life he was faithful and earnest and gave to public matters serious study and careful attention. He had a high appreciation of moral issues and was ever uncompromising on the side of right as he saw it.

In private life he was devoted to his family and to his friends.

*Now, Therefore, Be It Resolved,* That we deeply deplore his ultimately

passing, that we extend our sympathy to his bereaved family, and that an engrossed copy of this resolution be sent to them as a token of our affection and esteem for our departed comrade and friend.
