H. F. No. 588: Joint resolution providing for the appointment of a commission to promote the project of improvement, development, maintenance and protection of the Upper Mississippi, St. Croix and Minnesota Rivers for the purposes of navigation. (Received April 6.)

H. F. No. 706: An Act to provide for an additional judge of the Municipal Court of the City of Minneapolis. (Received April 5.)

H. F. No. 176: An Act relating to powers of county boards and authorizing the levy of an annual tax for the relief of county agricultural societies. (Received April 8.)

H. F. No. 232: An Act amending Sections 3 and 4, Chapter 345, General Laws 1923, relating to extension of time of payment of ditch liens in certain cases. (Received April 5.)
