**MEMORIAL**

To the Late

**SENATOR O. A. NAPLIN.**

The opening weeks of this session of the Legislature were saddened by the fatal illness and death of Senator O. A. Naplin of Thief River Falls. He was present when the oath of office was administered to the Senators-elect by Chief Justice Wilson on January 3. While leaving the capitol shortly thereafter, he was stricken with apoplexy and passed away on Saturday, January 15, at the Miller Hospital. The funeral services took place at Thief River Falls on January 17 and interment was made in the Black River Lutheran cemetery at Wylie. Senators Lee, Landby, Bessette, Sharpe and L. P. Lund were appointed by Lieutenant Governor Nolan to represent the Senate on this solemn occasion.

Oscar A. Naplin was born in Vastergotland, Sweden, May 2, 1876. When four years of age the boy accompanied his parents, Mr. and Mrs. Swan Naplin, to America and located on the Minnesota frontier in Black River township near Wylie, at that time in Polk County. Here his boyhood and youthful days were spent. Of studious bent, he made the most of his opportunities. He taught country school, attended the Gustavus Adolphus College, graduating in 1905. He taught at the Red Wing Seminary and later became high school principal at Carlton. He took the law course of the University of North Dakota and was admitted to the bar in 1910. He located for practice at Thief River Falls. He served as city attorney, and became active with cooperative and banking enterprises.

The late Senator Naplin was a progressive in his political views and attained a high standing in the Ninth District and the State, and usually could be counted upon to attend the state gatherings when called. He served as State Senator from Pennington, Red Lake and Clearwater counties in the sessions of 1919 and 1921. He was again elected to this position last fall. In 1924 he was a candidate for associate justice of the Supreme Court of Minnesota.

The deceased was a devoted member of his church, the Augustana Lutheran. He served the local congregation as secretary, was a member of the Synodical Board of Education and a life member of the North Star College corporation of Warren.

The late Senator is survived by his wife, Mrs. Laura (Johnson) Naplin, who was later elected by the people of the district to succeed her husband as a member of this Senate; a daughter, Arloine, 5 years; his aged father, 82; three brothers, John, Gustaf and Charles Naplin, and two sisters, Miss Anna Naplin and Mrs. O. G. Johnson—who will ever cherish the memory of the departed husband, father, son and brother with thankful hearts for what he has been to them.

Beautiful tributes to the life and work of Senator O. A. Naplin have been given expression by the newspapers of his district, the alumni association of the G. A. C., the clergy of his home city and elsewhere, the bar of his district, and his fellow citizens generally. He was one of God's noblemen in the truest sense—generous, manly and honest. His friendships were sacred to him. His public spirited activities in his home community life were unselfishly given and will be greatly missed. His was a strong character, loyal and sincere. He upheld what he believed to be right. Peace to his memory!
