

## MOTIONS AND RESOLUTIONS—CONTINUED.

Mr. Gibbons moved to amend H. F. No. 1157, the printed bill, as follows:

Page 1, Section 1, line 1, after the word "necessary" strike the comma and the words "may by public proclamation" and insert in lieu thereof the word "to".

Line 2, after the word "or" strike the word "such" and insert in lieu thereof the word "any". And further amend said line after the word "thereof" by striking the words "as he may designate"; and after the comma following the word "duty" by striking the word "and", and inserting after the word "may" the words "by public proclamation".

Page 2, Section 6(a), line 2, after the word "of" strike the word "another" and insert in lieu thereof the words "an adjoining".

Which motion prevailed and the amendment was adopted.

## UNANIMOUS CONSENT.

Mr. Ryberg asked unanimous consent to offer a resolution, and there being no objection, Mr. Ryberg offered the following resolution and moved its adoption.

*Whereas*, Almighty God, in His wisdom, called from this earth on August 31, 1940, the Honorable Ernest Lundeen of Wayzata, Minnesota, who served as a member of this House during the sessions of 1911 and 1913 and who later served as a Minnesota Representative in Congress and at the time of his death was serving as a United States Senator from Minnesota; and

*Whereas*, He offered his life in the service of his country as a member of the Minnesota Volunteers in the Spanish American War; and

*Whereas*, In his public life he was ever earnest and sincere and wholeheartedly devoted to the service of the best interest of the state and nation; and

*Whereas*, In his private life he was ever a kind and devoted friend and a gentleman in all his contacts with his fellowmen;

*Now, Therefore, Be It Resolved*, By the House of Representatives of the State of Minnesota that it hereby expresses its regrets at his untimely death and expresses its deep sympathy to his bereaved family and that a copy of the resolution as adopted be sent to the family as a mark of our esteem and token of appreciation for the public services he rendered.

*Be It Further Resolved*, That the Chief Clerk of the House of Representatives be and he is hereby instructed to send an engrossed copy of this resolution to the family of the deceased.

*Ladies and Gentlemen of the Minnesota House of Representatives:*

The tragic death of United States Senator Ernest Lundeen came to us all as a great shock. And to me it was a keen personal sorrow and loss. From boyhood days we were warm personal friends. His father was the able and respected pastor of the church at Harcourt, Iowa, where my father and mother and family worshiped. One of the first from Webster County, Iowa, to go to Carleton College, Northfield, Minnesota, I influenced my friend to go to Carleton. We were college chums. I remember how this fair-haired youth worked as janitor at the Y. M. C. A. at Northfield and did many other odd jobs to pay his way. He brought honor to his Alma Mater by winning the state oratorical contest. He was a clean, ambitious, diligent and exceedingly likeable college chap. While at Carleton he enlisted as a volunteer in the Spanish-American war. After graduation he studied law at the University of Minnesota and was subsequently admitted to the bar.

Mr. Lundeen was married in 1919 to Norma Ward of San Francisco, and two children were born to them, Ernest Ward and Norma Ward. Ernest Ward Lundeen, the son, is now following in his father's footsteps, working his way through Carleton College at Northfield, Minnesota.

Mr. Lundeen was every inch a soldier. But while he was an ardent champion for adequate defense of America and its institutions of representative government, his voice constantly rang out in a clarion call to his country to keep out of foreign wars and foreign entanglements. He served as a private in Company "B" 12th Regiment, Minnesota Volunteers in the Spanish-American war and served in the Minnesota National Guard, enlisting in Company "F" 1st Infantry on November 7, 1898, and served with the organization until August 1, 1901. He re-enlisted in the same company October 2, 1903, and served until October 19, 1910. On October 20, 1910, he was commissioned First Lieutenant and assigned to Company "F" 1st Infantry of the Minnesota National Guard, which commission he resigned on May 22, 1913. Mr. Lundeen was one of the best rifle and pistol shots in Minnesota, qualifying as expert in both arms many times.

Mr. Lundeen was elected to the Minnesota Legislature in 1910 and re-elected in 1912. In 1916 he was sent to Congress from the Fifth Congressional District of Minnesota. In 1932 he was again elected

to Congress from the Third Congressional District of the State, and in 1936 he became a Senator of the United States.

During his political career Mr. Lundeen distinguished himself as an able legislator and an orator of outstanding brilliance. He was a keen student of history and social problems. The down-trodden and needy always found in him a true and sympathetic friend. When the plane which carried him to his death crashed in a cornfield near Lovettsville, Virginia, August 31st, 1940, he was on his way to Minnesota to address a large assemblage of Townsend Clubs at Lake Minnetonka.

The State of Minnesota and the United States have lost an outstanding citizen and able statesman whose accomplishments, courage and valiant struggle will remain as an inspiration to all young men in this day and generation. The State of Minnesota and the country he loved so intensely will hold his memory in grateful and everlasting remembrance for his contribution to important and progressive legislation.
