Wednesday, January 4, 1871.

The House met at the usual hour and was called to order by the Speaker.

Prayer by the Chaplain.

The roll being called the following members were found to be absent: Messrs. Barton, Couplin, Densmore, Flood, Moore and Wedge. The journal of yesterday was read and approved.

The Speaker announced that he had received the testimony and other papers pertaining to the contested election case from the 20th Legislative District, wherein A. L. Patchin is contestant, and G. C. Chamberlain respondent.

Mr. Honner presented a petition from Henry Luscher and others, praying for the confirming of their name as Luscher, for certain rea-

sons therein named.

Which was laid on the table for reference.

Mr. Fowler asked for three days leave of absence for Mr. Moore. Which was granted.

The committee appointed to confer with a similar committee from the Senate, for the purpose of arranging for canvassing the votes cast at the last general election of State officers, and on the various proposed Constitutional amendments,

Report 101 o'clock to-day as the hour fixed for such convention, and

the Hall of the House of Representatives as the place thereof.

On motion ot Mr. Hall the House took a recess until 10½ o'clock, to prepare for joint convention.

The hour of 10½ o'clock having arrived, the members and officers of

H. F. No. 38, A bill for an act for the removal of the county seat of Kandiyohi county from Kandiyohi Station to Wilmar,

Was read the third time and put upon its final passage.

The question being taken upon the passage of the bill, there were yeas 32, and nays none as follows:

H. F. No. 42, A bill for an act to amend title three of chapter sixtyfive of the general statutes of this State, relating to pleadings and trials in justices courts.

Was read the third time and put upon its final passage.

The question being taken upon the final passage of the bill, there were yeas 25, and nays 10, as follows:

The Sergeant-at-Arms was ordered to report the absentees in their seats, except Messrs. Hyde and Telfer, who had leave of absence.

On motion of Mr. Meagher, further proceedings under the call were dispensed with.

Mr. Atwater offered the following resolution:

Resolved, That A. L. Petchin received a majority of all the legal votes cast for member of the House of Representatives for this State in the present session in the 20th Senatorial District, and that he is entitled to his seat in this body.

The question being taken on the adoption of the resolution,

And the yeas and nays being ordered, there were yeas 28, and nays 12, as follows:

Mr. Colburn offered the following resolution which was unanimously adopted:

Resolved, That while in the opinion of this House a gross fraud was committed at the late election in the town of Blue Earth city, the effect of which deprives George C. Chamberlain, of the Twentieth Senatorial District, of his seat in this House, yet there is no evidence produced tending to show that said Chamberlain was in any manner responsible for, or had any knowledge of the perpetration of said fraud.

On motion of Mr. Sibley, Mr. Patchin appeared within the bar of the House, and took the oath of office as member from the 20th Legislative District.

The Speaker announced that Mr. Patchin would occupy the same position on the several committees as were occupied by Mr. Chamberlain.

On motion of Mr. Washburn, the rules were suspended, and the
