Whereas, Honorable Albert J. Peterson, a member of the House of Representatives during the sessions of 1911 and 1913, from Lac qui Parle County, and later in the year 1925 the 1st Budget Commissioner under the Reorganization Act of 1923, was called by Almighty God to his eternal reward on June 1st, 1943; and

Whereas, His life was an example and inspiration for the present and succeeding generations of citizens of this state; and

Whereas, In his contacts with his fellowmen he was earnest, sincere, congenial and kindly, and in his public life wholeheartedly devoted to the service of the best interests of the state; and

Whereas, During his long and distinguished public service he also occupied the positions of President of Village Council and Member of Board of Education at Dawson, Minnesota, and other important public offices; Now therefore

Be It Resolved, That the House of Representatives of the State of Minnesota, hereby declare our sense of loss because of Mr. Peterson's death, and extend our deepest sympathy to his bereaved family; and that a copy of this resolution be sent to his family as a mark of our

esteem, and as a token of our affection for our departed comrade and friend.
