Later, he served the state, being in the legislature for two terms. He was postmaster at Dodge Center for sometime, also clerk of the School Board for years. M., Kasson, Commandery No. 5, Rochester, Osman Temple, St. Paul, and the Odd Fellows, and Knights of Pythias of Dodge Center.

While not a member of a church, Mr. Schwarg was by nature and vaining deeply religious. The Bible and religious books comprised his reading of late years. He was a regular attendant of the Congregational church and for a long time served on its Board.

Mr. Schwarg was twice married, the first wife, Pauline Getman, the mother of his children, preceded him to the other shore many years ago. Later he married Genevieve A. n., who, with the sons, Henry J., Charles E., and Carolyn, the devoted daughter, together with a grand-daughter, Mrs. Henry Harm, all of Minneapolis, and one brother, Mike F. Buckman of Kasson, survive him. All of these were present at the funeral.
