Messrs. Dalager and Lagerstedt introduced the following resolution: Whereas, Death has called during the past week the Honorable E. P. Skaiem, who served as a member of the Minnesota House of Representatives from the sixty-third District during the 1919, 1923 and 1925 Sessions,

Therefore Be It Resolved, By a rising vote that this House honors and respects the memory of the deceased, the Honorable E. P. Skaiem, in appreciation of his sterling qualities of mind and of heart, and that it extends to his bereaved family its sympathy.

And Be It Further Resolved, That an engrossed copy of this Resolution be transmitted by the Chief Clerk of the House to the family of the deceased.

Which resolution was unanimously adopted by a rising vote.

GENERAL ORDERS.

The House resolved itself into a Committee of the Whole, with Mr. Masek in the chair.

Line 4, strike out the word "fifty" and the parentheses enclosing the figure "\$50.00", in line 5 strike out the word "dollars", in line 10 strike out figure "6" and parentheses enclosing same, in line 11 strike out words "two hundred and fifty dollars" and the parentheses enclosing the figure "\$250.00", in line 15 strike out word "fifty", in line 16 strike out parentheses enclosing the figure "\$50.00" and the word "dollars".
