- 1.1A bill for an act
- 1.2relating to public safety; providing that certain law enforcement training
- 1.3reimbursement funding is ongoing; amending Laws 2021, First Special Session
- 1.4chapter 11, article 1, section 15, subdivision 3, as amended.
- 1.5BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
- 1.6Section 1. Laws 2021, First Special Session chapter 11, article 1, section 15, subdivision
- 1.73, as amended by Laws 2023, chapter 52, article 2, section 10, is amended to read:
- 1.8Subd. 3. **Peace Officer Training Assistance**
- 1.9**Philando Castile Memorial Training Fund**
- 1.10\$6,000,000 each year is to support and
- 1.11strengthen law enforcement training and
- 1.12implement best practices. This funding shall
- 1.13be named the "Philando Castile Memorial
- 1.14Training Fund." These funds may only be used
- 1.15to reimburse costs related to training courses
- 1.16that qualify for reimbursement under
- 1.17Minnesota Statutes, sections 626.8452 (use of
- 1.18force), 626.8469 (training in crisis response,
- 1.19conflict management, and cultural diversity),
- 1.20and 626.8474 (autism training).
- 1.21Each sponsor of a training course is required
- 1.22to include the following in the sponsor's
- 1.23application for approval submitted to the

2.1 board: course goals and objectives; a course
2.2 outline including at a minimum a timeline and
2.3 teaching hours for all courses; instructor
2.4 qualifications; and a plan for learning
2.5 assessments of the course and documenting
2.6 the assessments to the board during review.
2.7 Upon completion of each course, instructors
2.8 must submit student evaluations of the
2.9 instructor's teaching to the sponsor.

2.10 The board shall keep records of the
2.11 applications of all approved and denied
2.12 courses. All continuing education courses shall
2.13 be reviewed after the first year. The board
2.14 must set a timetable for recurring review after
2.15 the first year. For each review, the sponsor
2.16 must submit its learning assessments to the
2.17 board to show that the course is teaching the
2.18 learning outcomes that were approved by the
2.19 board.

2.20 A list of licensees who successfully complete
2.21 the course shall be maintained by the sponsor
2.22 and transmitted to the board following the
2.23 presentation of the course and the completed
2.24 student evaluations of the instructors.
2.25 Evaluations are available to chief law
2.26 enforcement officers. The board shall establish
2.27 a data retention schedule for the information
2.28 collected in this section.

2.29 Each year, if funds are available after
2.30 reimbursing all eligible requests for courses
2.31 approved by the board under this subdivision,
2.32 the board may use the funds to reimburse law
2.33 enforcement agencies for other
2.34 board-approved law enforcement training
