- 1.4BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
- 1.5Section 1. Minnesota Statutes 2024, section 609.324, subdivision 1, is amended to read:
- 1.6Subdivision 1. **Engaging in, hiring, or agreeing to hire minor to engage in**
- 1.7**prostitution; penalties.** (a) Whoever intentionally engages in prostitution with an individual
- 1.8under the age of 14 years may be sentenced to imprisonment for not more than 30 years or
- 1.9to payment of a fine of not more than \$40,000, or both.
- 1.10**(b)** Whoever intentionally does any of the following may be sentenced to imprisonment
- 1.11for not more than 20 years or to payment of a fine of not more than \$40,000, or both:
- 1.12~~(1) engages in prostitution with an individual under the age of 14 years;~~
- 1.13~~(2)~~ (1) hires or offers or agrees to hire an individual under the age of 14 years to engage
- 1.14in sexual penetration or sexual contact; or
- 1.15~~(3)~~ (2) hires or offers or agrees to hire an individual who the actor reasonably believes
- 1.16to be under the age of 14 years to engage in sexual penetration or sexual contact.
- 1.17**(c)** Whoever intentionally engages in prostitution with an individual under the age of
- 1.1816 years but at least 14 years may be sentenced to imprisonment for not more than 15 years
- 1.19or to payment of a fine of not more than \$30,000, or both.

2.13 or to payment of a fine of not more than \$20,000, or both.

2.14 ~~(e)~~ (f) Whoever intentionally does any of the following may be sentenced to imprisonment
2.15 for not more than five years or to payment of a fine of not more than \$10,000, or both:

2.18 ~~(2)~~ (1) hires or offers or agrees to hire an individual under the age of 18 years but at
2.19 least 16 years to engage in sexual penetration or sexual contact; or

2.20 ~~(3)~~ (2) hires or offers or agrees to hire an individual who the actor reasonably believes
2.21 to be under the age of 18 years but at least 16 years to engage in sexual penetration or sexual
2.22 contact.

2.23 **EFFECTIVE DATE.** This section is effective August 1, 2025, and applies to crimes
2.24 committed on or after that date.
