

Legislative Commission on Pensions and Retirement (LCPR)

Responsibilities:

- Hearings on pension and retirement-related bills, for possible inclusion in an annual omnibus pension bill
- Oversight of the state's 14 pension and retirement plans for public employees and 500+ firefighter relief association plans
- Staff drafts pension and retirement-related bills and provides policy and legal analysis

\$1,332,000

Legislative Coordinating Commission (LCC)

- Provide fiscal services (HR, accounting, etc.) for joint offices and commissions
- Staff joint commissions, working groups, and task forces
- Geographic information services (GIS)-- mapping
- Service as the fiscal agent for and coordinate legislative wide activities

FY26-27 Base Budget:

\$4,344,000 operating \$5,518,000 fiscal agents
