RE: RAMS comments regarding HF 8 (Heintzeman)

Representative Heintzeman:

On behalf of the Range Association of Municipalities and Schools (RAMS), representing 69 local units of government in the Taconite Assistance Area (TAA), and serving over 155,000 residents in 27 cities, 27 townships, and 15 school districts in the 13,000 square miles of northeastern Minnesota commonly known as the Iron Range, we would encourage committee support for HF 8 (Heintzeman) as well as future dialogue and development of this timely, impactful, and important piece of legislation.

RAMS was formed in 1939 to promote and serve the regional needs of Northeastern Minnesota communities on the Iron Range. We have lived the impact of broken permitting and regulatory processes firsthand and hope to see a resolution to this ongoing issue. In addition to the many fine and necessary provisions contained in HF 8, in its current form, we would encourage additional discussion and development on the bill, including, but not limited to:

- Strengthen the Ombudsman language to include cross- and inter-agency accountability. Consider this not as a "single person" model, but a distributed leadership model with multiple touch points and built in accountability. Encourage more front-facing checklists and outcome-oriented processes.
- Addition of a community/labor/industry panel (with report required) to develop a plan for ongoing continuous improvement (CI) of Agency processes.
- Incentivize agency level decision-making: Reflect on the current state of hiring additional permitting professionals and what changes may be relevant. Currently, the "pay to expedite" feature, as it currently stands is not incentivizing agency level decision making.
- Concerned that eliminating the scoping process for mandatory EIS, which is meant to limit the breadth of issues covered in an EIS, moves everything to the EIS, creating a "high stakes" situation as items that would have been deemed not significant now have equal treatment as issues that are significant.
- Consider ways to support agency staff by reframing and removing "reporting for failure". Current reporting methods focus on tracking and cataloging failure, rather than focusing on continuous improvement and dialogue between staff, community, and project proposers.
