HOUSE CONCURRENT RESOLUTION NO. 11

A house concurrent resolution designating May 1st of each year as Law Day U.S.A.

Whereas, Law Day was established by an act of Congress in 1961 as an annual observance on May 1st; and

Whereas, citizens today enjoy more rights, greater access to our courts and more ways and means of equitably resolving disputes than ever before; and

Whereas, as citizens of this state and nation, it is proper that we reflect on our great heritage and participate in bar association sponsored community programs in recognition of the special day set aside by the Congress of the United States; and

Whereas, in order to recedicate ourselves to the principles of the democratic form of government; to emphasize that ours is a government of laws and not of men; and to further the philosophy that "the welfare of the people shall be the supreme law"; now, therefore,

Be It Resolved, by the House of Representatives of the State of Minnesota, the Senate concurring therein, that the Governor of Minnesota is requested to designate and dedicate May 1st of each year as Law Day U.S.A.; and

Be It Further Resolved, that it is not the purpose of this resolution to declare another holiday, but only to designate a day for rededication by the citizens of Minnesota to the principles of democracy, a respect for the law that is so vital to the democratic way of life, and to the support of our state and federal courts of law which uphold and safeguard individual rights and liberties.

Be It Resolved, by the House of Representatives of the State of Minnesota that March 16, 1977 and March 16 of all years to come be recognized as St. Urho's Day in Minnesota and celebrated accordingly by all people of Finnish descent and friends.

- (b) "Beer" means and includes intoxicating and non-intoxicating malt liquor, as defined in chapter 340.
- "Beverage container" means an individual, hermetically sealed, glass, metal or plastic bottle, can or jar filled with beer or carbonated soft drinks.
- "Refillable beverage container": A beverage container is refillable if it is capable of being refilled at least five times and if the majority of beverage containers of identical size and construction filled with the same brand of beer or carbonated soft drinks are refilled at least five times for retail sale.
- "Non-refillable beverage container" means any beverage container other than a refillable beverage container.
- Subd. 2. No retailer shall sell or offer for sale and consumption upon his premises any beer or carbonated soft drink dispensed from non-refillable beverage containers; except that any brand of beer or carbonated soft drinks sold in a non-refillable beverage container in this state prior to March 1, 1978, but not sold in a refillable beverage container, may be sold or offered for sale in non-refillable beverage containers until such time as that brand is sold or offered for sale in a refillable beverage container in this state.
- Subd. 3. A retailer who sells or offers for sale beer or carbonated soft drinks for off-premises consumption shall devote in the ordinary course of business an amount of display area of beverage in refillable containers substantially equal to or greater than the amount of display area of beverage in non-refillable containers.
- Subd. 4. No retailer shall sell or offer for sale beer or carbonated soft drinks in non-refillable beverage containers in less than case lots unless the retailer also sells or offers for sale beer or carbonated soft drinks in refillable beverage containers in less than case lots.

- Subd. 5. A retailer who sells or offers for sale beer or carbonated soft drinks for off-premises consumption, either in individual beverage containers or in groups of beverage containers as a packaged unit, shall display prominently on his premises the refund value of the empty beverage container, if any, and the retail price per pint, excluding the refund value, of the filled beverage container.
- Subd. 6. No person shall sell or offer for sale beer or carbonated soft drinks in non-refillable beverage containers on any property owned by the state of Minnesota or the university of Minnesota.
- Subd. 7. Any person who violates any provision of this section is guilty of a misdemeanor.".

Further, amend the title as follows:

Strike lines 2 to 25 and insert "requiring certain retail practices of retailers selling certain beverages; prohibiting certain non-refillable beverages from being sold on state property.".

The appeal shall be taken within 15 days after the date of the resolution setting such salary or budget by serving a notice of appeal on the county auditor and filing same with the clerk of the district court. On the hearing of the appeal the court shall review the decision or resolution of the board in a hearing de novo and may hear new or additional evidence, or the court may order the officer appealing and the board to submit briefs or other memoranda and may dispose of the appeal on such writings. After determination of the appeal the county board shall proceed in conformity therewith.
