BE IT RESOLVED, by the Senate, that the following named person be and is hereby appointed to the position hereinafter stated and at the salary heretofore fixed.

Mr. Conzemius moved the adoption of the foregoing resolution. The motion prevailed. So the resolution was adopted.

Mr. Coleman, for the Committee on Rules and Administration, offered the following resolution:

Senate Resolution No. 40: A resolution relating to the use of the Senate Chamber, committee rooms, etc. during interim between the 1974 session and the 1975 session.

BE IT RESOLVED, by the Senate, that for the period between the close of the 1974 session and the convening of the 1975 session, the Senate Chamber, retiring room, committee rooms, all conference rooms, storage rooms, Secretary of the Senate's office, Rules and Administration office, and any and all other space assigned to the Senate, shall be reserved for use by the Senate and its standing committees only and shall not be released or used for any other purpose except upon authorization of the Secretary of the Senate with the approval of the Committee on Rules and Administration except that the Senate Chamber, Senate retiring room and such committee rooms as are available may be released by the Secretary of the Senate and be available to the Hi-Y Model Legislature and to the Girls' State. Provided, however, that the

Senate Chamber and Senate retiring room shall not be let out for any purpose during the months of November and December prior to a session of the legislature except upon approval of the Committee on Rules and Administration.

BE IT FURTHER RESOLVED, that the custodian of the State Capitol shall be instructed to keep the corridors and rotunda, insofar as is possible, clear of all furniture and equipment and that all Senate furniture remain in the committee rooms and offices, except as otherwise directed by the Secretary of the Senate upon approval of the Committee on Rules and Administration.

BE IT FURTHER RESOLVED, the Commissioner or Administration shall be and is hereby instructed to furnish permits through the Secretary of the Senate to members of the Minnesota State Senate and authorized staff for parking facilities on Aurora Avenue and other areas as may be required for the period between the close of the 1974 session and the convening of the 1975 session.

1) In behalf of Senate employees for regular and special services rendered prior to, during and following the 1974 legislative session;

2) For postage and other expenses of the Secretary of the Senate's office;

3) For roll call and public address system maintenance, improvement, repair or replacement;

4) For expenses of members in visiting state institutions;

5) For demoting, repairing or replacing the Senate Chamber carpeting;

6) For supplies and office equipment;

9) For such election and litigation costs as are authorized by the Committee on Rules and Administration;

Mr. Coleman, for the Committee on Rules and Administration, offered the following resolution:

Senate Resolution No. 43: A resolution relating to standing committees of the Senate.

BE IT RESOLVED, that the Committee on Rules and Administration may from time to time assign to the various committees of the Senate, in the interim, matters brought to its attention by any member of the Senate for study and investigation. In addition, the standing committees and subcommittees may study and investigate all subjects that come within their usual jurisdiction, as provided by Minnesota Statutes, Section 3.921. A committee shall carry on its work by subcommittee or by committee action as the committee from time to time shall determine. Any study undertaken by any of the standing committees, or any subcommittee thereof, shall be coordinated to the greatest extent possible with other standing committees or subcommittees of the Senate and the House of Representatives, and may, if the committee or subcommittee shall so determine, be carried on jointly with another committee or subcommittee of the Senate or House of Representatives. Each committee shall file with the Secretary of the Senate at the opening of the next regular legislative session a report containing its findings and recommendations concerning the studies assigned to it.

BE IT FURTHER RESOLVED, that the Lobby Registration Committee, between the close of the 1974 session of the Legislature and the adoption of the Rules of the Senate for the 1975 legislative session shall continue to perform the duties and to exercise all the powers prescribed by Senate Rule 79, and for the purposes of Min-

nesota Statutes, Sections 3.153 and 3.921 the Lobby Registration Committee shall be considered a standing committee of the Senate, and shall conduct such public hearings and investigations of lobbyists' activities as the Committee on Rules and Administration may direct.

BE IT FURTHER RESOLVED, that all employees needed to carry out the functions of the Senate during the period between the adjournment of the Sixty-eighth legislature and the convening of the Sixty-ninth legislature, shall be employed by the Committee on Rules and Administration, or a subcommittee thereof and be under its direction and control. Said employees shall be paid upon the abstract of the Secretary of the Senate at the salary rates fixed by the Committee on Rules and Administration.

BE IT FURTHER RESOLVED, that the Committee on Rules and Administration shall allocate the amount of expenses to each of the committees or subcommittees designated for the purpose stated herein; that all monies so allocated shall be paid from the legislative expense fund and the monies appropriated therein for standing committees.

BE IT FURTHER RESOLVED, that the Committee on Rules and Administration may authorize members of the Senate and personnel employed by the Senate to travel and to attend courses of instruction or conferences for the purpose of improving and making more efficient Senate operation and may reimburse such persons for the costs thereof out of monies appropriated to the Senate for the standing committees.

BE IT FURTHER RESOLVED, that all members of standing committees or subcommittees of the Senate and staff shall be reimbursed for all expenses actually and necessarily incurred in the performance of their duties in the manner provided by law. Such payment shall be made by the Secretary of the Senate out of monies appropriated to the Senate for the standing committees; that the Committee on Rules and Administration shall determine the amount and manner for reimbursement for living and other expenses of each member of the Senate incurred in the performance of his duties when the legislature is not in regular session.

BE IT FURTHER RESOLVED, that the Secretary of the Senate and other personnel employed by the Senate in an executive capacity shall report to the Committee on Rules and Administration at its regularly scheduled meetings regarding matters coming under their jurisdiction.

Mr. Conzemius moved the adoption of the foregoing resolution.

Mr. Coleman, for the Committee on Rules and Administration, introduced—

Senate Resolution No. 44: A resolution relating to the office of the Secretary of the Senate, legislative printing and binding contracts, office supplies, equipment, records and expenses.

BE IT RESOLVED, by the Senate, that the position of the Secretary of the Senate shall be continued until the next regular legislative session. He is hereby authorized and directed to maintain the offices of the Secretary of the Senate and to employ for the interim between the close of the 68th legislature and the convening of the 69th legislature, an office secretary and any other personnel required for Senate services as directed by the Committee on Rules and Administration.

That the Secretary of the Senate be authorized to employ after the close of the session such employees as may be necessary to finish the business of the Legislature at such salaries paid such employees under the Rules of the Senate for the 68th Legislature, second session.

That during said interim, but not including time which may be spent in any special session, the Secretary of the Senate shall be paid for services rendered the Senate at the salary rate established for that position for the 68th legislature, second session, unless otherwise directed by the Committee on Rules and Administration, plus travel and subsistence expense incurred incidental to his Senate duties, including salary and travel expense incurred in attending the annual meeting of the Secretaries and Chief Clerks National Legislative Conference sponsored by the Council of State Governments.

BE IT FURTHER RESOLVED, that the Secretary of the Senate, with the approval of the Committee on Rules and Administration, is hereby authorized and directed to secure bids and enter into contracts for the printing of the daily Senate journals, bills, general orders, special orders, calendars, resolutions, printing and binding of the permanent Senate Journal, and other printing required by the Senate for the 69th legislature and/or any special session called prior to the 70th regular sessions of the legislature; that any contracts awarded shall be signed by the Chairman of the Committee on Rules and Administration and such other member as the Committee on Rules and Administration shall designate.

BE IT FURTHER RESOLVED, that the Secretary of the Senate, with the approval of the Committee on Rules and Administration, is hereby authorized and directed to purchase office supplies and equipment required for the interim and to negotiate for essential office supplies and equipment which must be pre-ordered to insure delivery for the Senate at the next session of the legislature.

BE IT FURTHER RESOLVED, that all Senate records, including committee books, after the adjournment sine die of the 68th legislature, and prior to the convening of the 69th legislature, shall be subject to the direction of the Committee on Rules and Administration.

BE IT FURTHER RESOLVED, that the Secretary of the Senate, with the approval of the Committee on Rules and Administration, may reimburse members of the Senate, upon proper verification of the expenses incurred, for long distance telephone calls after the adjournment sine die of the 68th legislature and prior to the convening of the 69th legislature.

BE IT FURTHER RESOLVED, that the Secretary of the Senate is hereby authorized and directed to draw warrants from the Legislative Expense Fund in payment of the accounts herein referred to as they apply to such funds.

BE IT FURTHER RESOLVED, that the Secretary of the Senate is hereby directed to implement Minnesota Statutes, Section 3.095. The term "permanent" shall mean all employees heretofore certified by the Committee on Rules and Administration and the Secretary of the Senate as permanent employees and those hereinafter certified by the Committee on Rules and Administration and the Secretary of the Senate as permanent.

BE IT FURTHER RESOLVED, that should a vacancy occur in the position of Secretary of the Senate, by resignation or other causes, the Committee on Rules and Administration shall appoint an acting Secretary of the Senate who shall serve in such capacity during the remainder of the interim between the adjournment of the 68th legislature, second session and the convening of the 69th legislature, under the provisions herein specified.

I am returning S. F. No. 3352, a bill relating to the fire service in the City of Richfield, without my signature.

This bill allows the City of Richfield to remain eligible for state aid without maintaining both the positions of fire chief and assistant fire chief.

I have no quarrel with the basic purpose of this bill; I believe it is legitimate.

Nevertheless, respected persons in the fire service profession are genuinely concerned that S. F. No. 3352, if enacted into law, would bring long-term harm to those responsible for fire protection in Minnesota.

Therefore, I believe that any decision on my part must balance the authors' purpose with the deep anxiety of the fire service profession.

In light of the profession's concern, I firmly believe that the issue inherent in this legislation must be given careful and thorough reevaluation by the next Legislature. If, after further study and consultation with members of the fire service profession, the Legislature believes S. F. No. 3352 will contribute to better community fire protection, then I will be happy to reconsider the bill.
