anniversary of the birth of Dr. King; now, therefore,

BE IT RESOLVED, by the Senate of the State of Minnesota, that recognition and tribute be given to Dr. Martin Luther King on this, the fifty-second anniversary of his birth.

BE IT FURTHER RESOLVED, that the Secretary of the Senate of the State of Minnesota transmit a formal copy of this resolution to his wife, Mrs. Coretta King.
