"Sec. 2. Minnesota Statutes 1980, Section 368.01, Subdivision 21, is amended to read:

Subd. 21. [ENACTMENT OF ORDINANCES.] Every ordinance shall be enacted by a majority vote of all the members of the town board except where a larger number is required by law. It shall be signed by the chairman of the town board, attested by the clerk and published once in the official newspaper. If the town board determines that publication of the complete text of an ordinance is not worth the expense and that a summary would adequately inform the public of the intent of the ordinance, the town board may by majority vote direct that only the title of the ordinance and a summary be published with notice that printed copies of the ordinance are available to any person during regular office hours of the town clerk and any other location which the council designates. Prior to the publication of the title and summary the town board shall approve the text of the summary and determine that it adequately informs the public of the intent of the ordinance. The text of the summary shall be published in a body type no smaller than brevier or eight-point type, as defined in section 331.07. Proof of the publication shall be attached to and filed with the ordinance. Every ordinance shall be recorded in the ordinance book within 20 days after its publication of the ordinance or its title and summary. All ordinances shall be suitably entitled and shall be substantially in the style: "The Town Board of Supervisors . . . ordains: '.'

Amend the title as follows:

Page 1, line 2, before the semicolon insert "and urban towns"

Page 1, line 4, delete "Section" and insert "Sections 368.01, Subdivision 21; and"
