The commissioner shall consider this information in an appropriate manner in adopting a schedule of rates, giving explicit consideration to the income on invested reserves of the Minnesota members of the rating association, and shall decline to grant a hearing pursuant to section 79.071 if the association fails to provide the information; provided, however, to the extent that the information received in a pending or future petition for a modification of the existing schedule of rates is insufficient to allow the commissioner to give explicit consideration to the income on invested reserves of the Minnesota members of the rating association, the commissioner shall withhold a final determination with respect to the adoption of a schedule of rates pursuant to section 79.071, subdivisions 4 and 5; and, provided further, if the commissioner withholds final consideration pursuant to this section, then he shall hold additional hearings as he deems necessary and the provisions of section 79.071, subdivision 5, shall not apply."
