No. 350: A bill for an act relating to crime; extending the crimes of murder in the third degree and manslaughter in the first degree to deaths caused by the sale or distribution of controlled substances; making it a felony to cause great bodily harm by selling or distributing certain controlled substances; imposing penalties; amending Minnesota Statutes 1986, sections 609.195; and 609.20; proposing coding for new law in Minnesota Statutes, chapter 609. Referred to the Committee on Rules and Administration for comparison with S.F. No. 1259, now on General Orders.

Page 6, line 16, after the comma, insert "and" and delete everything after the first "not" and insert "a passenger in the vehicle at the time of the violation."

Page 6, delete lines 17 to 19

Page 6, line 27, delete "while" and insert "issuance of" and delete "is"

Page 6, line 28, before the comma, insert "for a motor vehicle owned by a person who has violated section 169.121 or 169.123"

Page 6, line 29, after the period, insert "A person who owns a vehicle subject to an impoundment order and who was not the driver of the vehicle at the time of the violation may petition the court for review at any time while the order is in effect."

Page 7, line 15, before "A" insert "(a)"

Page 7, line 32, before the first "The" insert "(b)" and strike the second "the" and insert "a" and after "hearing" insert "for review of a license revocation under this section"

Page 8, after line 21, insert:

"(c) The scope of a hearing for review of an impoundment order under section 168.041 shall include:

(1) whether the vehicle subject to the impoundment order is individually or jointly owned by a person whose driver's license has been revoked for a violation of section 169.121 or 169.123 a second or subsequent time within five years or a third or subsequent time within ten years; or

(2) whether the vehicle is owned by a person who was a passenger in

the vehicle at the time the driver committed a violation resulting in the revocation of the driver's license for a violation of section 169.121 or 169.123 a second or subsequent time within five years or a third or subsequent time within ten years.

Certified or otherwise authenticated copies of driver's license and motor vehicle registration records shall be admissible as substantive evidence."

Page 8, line 22, before the first "The" insert "(d)"

Page 8, line 34, delete everything after the period

Page 8, delete lines 35 and 36

Page 9, delete lines 1 to 8

Page 9, after line 34, insert:

"Sec. 8. [APPROPRIATION.]

\$150,000 is appropriated from the general fund to the attorney general to pay increased costs of implied consent hearings due to this act. \$80,000 is for fiscal year 1988 and \$70,000 is for fiscal year 1989. The approved complement of the office of the attorney general is increased by two and one-half positions."
