Dear Mr. President:

I have today signed into law Chapter 565, S.F. No. 2617, the omnibus Agriculture, Transportation and Semi-States appropriations bill. However, I have, pursuant to the powers vested in me by Article IV, Section 23 of the Minnesota Constitution, determined to line-item veto the following provision in this bill relating to the World Trade Center:

Sec. 10, page 4, line 29, which reads as follows:

(a) General reduction (50,000)

This reduction would severely curtail Minnesota's ability to continue planning for increased trade opportunities with the European Economic Community, Eastern Europe and the Soviet Union.

Pursuant to the requirement of Article IV, Section 23 of the Minnesota Constitution, an executed copy of this letter has been appended to the bill as filed with the Secretary of State.
