Senate Resolution No. 88: A Senate resolution relating to ethical conduct; conduct of Senator Kevin M. Chandler.

WHEREAS, the Subcommittee on Ethical Conduct of the Committee on Rules and Administration, based on clear and convincing evidence, has made the following findings:

(1) Kevin M. Chandler was first elected to the Minnesota Senate in 1992, representing District 55.

(2) On the night of July 26, 1995, during the interim between the 1995 and 1996 sessions of the Legislature, Senator Chandler became involved in an argument with his estranged wife in the parking lot of O'Gara's Bar, 164 North Snelling Avenue, St. Paul, shortly after 11 p.m.

(3) During the course of the argument, Senator Chandler slapped his wife in the face with his open hand.

(4) On August 8, 1995, Senator Chandler requested that he be charged with assault in the fifth degree.

(5) On August 11, 1995, before the Honorable Kathleen Gearin, Judge of Ramsey County District Court, Senator Chandler pleaded guilty to a violation of Minnesota Statutes, section 609.224, assault in the fifth degree, a misdemeanor.

(6) On September 21, 1995, Judge Gearin, acting under Minnesota Statutes, section 609.135, stayed imposition of sentence for one year, during which time Senator Chandler will be on probation on the following conditions:

(a) That he pay court costs in the amount of \$210.

(b) That he follow all the recommendations of a probation officer.

(c) That he remain law-abiding.

(7) On October 3, 1995, Senator Chandler resigned his positions as Vice-Chair of the Committee on Environment and Natural Resources, Chair of the Environmental Protection Subcommittee of the Committee on Environment and Natural Resources, Chair of the Employment Subcommittee of the Committee on Jobs, Energy, and Community Development, and his position as Majority Whip.

(8) Senator Chandler has complied with all conditions imposed by the court, including a six-week domestic abuse education program.

(9) On December 27, 1995, Senator Chandler announced that he would not be a candidate for reelection in 1996.

(10) On January 3, 1996, Senator Chandler submitted to the Chair of the Subcommittee his written apology to the Senate.

NOW, THEREFORE,

BE IT RESOLVED, by the Senate of the State of Minnesota:

(1) That the conduct of Senator Kevin M. Chandler in slapping his wife was criminal.

(2) That Senator Kevin M. Chandler's decision voluntarily to resign his leadership positions in the Senate was an appropriate disciplinary action.

(3) That Senator Kevin M. Chandler be required to apologize to the Senate in open session.

Mr. Frederickson moved the adoption of the foregoing resolution.

Without objection, Mr. Chandler was excused from voting on the resolution.

The question was taken on the adoption of the resolution.

The roll was called, and there were yeas 63 and nays 0, as follows:

The motion prevailed. So the resolution was adopted.

Pursuant to the foregoing resolution, Mr. Chandler apologized to the Senate.

Mr. Solon apologized to the Senate before the adoption of the following resolution.

Messrs. Moe, R.D. and Johnson, D.E. introduced--

Senate Resolution No. 89: A Senate resolution relating to ethical conduct; conduct of Senator Sam G. Solon.

WHEREAS, the Subcommittee on Ethical Conduct of the Committee on Rules and Administration, based on clear and convincing evidence, has made the following findings:

(1) Sam G. Solon was first elected to the Minnesota House of Representatives in 1970 and was first elected to the Minnesota Senate in 1972. He was reelected in 1976, 1980, 1982, 1986, 1990, and 1992. He currently represents District 7.

(2) The marriage of Sam G. Solon and Paula Solon was dissolved in 1988.

(3) Senator Solon provided the Senate's long-distance telephone access code to his ex-wife, Paula Solon, after their marriage was dissolved.

(4) During the years 1992 and 1993, Paula Solon did not perform any legislative business for the Minnesota State Senate. Senator Solon knew that she was not performing any legislative business for the Senate.

(5) Paula Solon says that Senator Solon authorized her to provide the Senate's access code to her mother, Ann Tool. Ann Tool did not perform any legislative business for the Minnesota State Senate. Senator Solon does not recall granting that authorization.

(6) The Senate's access code was changed in August 1992 and January 1993. Senator Solon provided Paula Solon with the new access code each time it was changed.

(7) During the years 1992 and 1993, telephone calls traced to Paula Solon's use of the Senate's access code totaled \$2,431.

(8) Paula Solon's use of the Senate's access code terminated in March 1993.

(9) In March 1993, in response to reports about abuses of the House telephone system by Representative Allan Welle, the Secretary of the Senate began reviewing the Senate's telephone records to determine whether there might be similar problems in the Senate.

(10) With the aid of information provided by Senator Solon's long-time friend and roommate, Charles Westin, including the home and business telephone numbers of the persons to whom Senator Solon and Mr. Westin had given the Senate's access code, the Secretary of the Senate was able to determine the cost of the long-distance telephone calls made from those numbers and charged to the Senate. The cost was approximately \$3,000.

(11) Senator Solon did not disclose to the Secretary of the Senate, who he knew was investigating his unauthorized calls, that he had given the Senate's access code to Paula Solon.

(12) By his personal checks dated April 13, 1993, and May 4, 1993, Senator Solon made full restitution to the Senate of amounts paid by the Senate for the long-distance calls of Charles Westin, Don Johnson, Ronald Limoseth, Constance Limoseth, and Tom Bergh.

(13) On May 12, 1993, Senator Solon publicly apologized to the Senate for the embarrassment, notoriety, and public ridicule that his indiscretion in giving out the Senate's long-distance telephone access code had inflicted upon the Senate.

(14) On March 24, 1994, by Senate Resolution No. 68, 1994 JOURNAL OF THE SENATE 6871, Senator Solon was formally reprimanded by the Senate for his conduct in providing the Senate's long-distance telephone access code to others and for allowing others to use his Senate office and telephone to make calls on their own personal and private business.

(15) The Ramsey County Attorney began an investigation of the long-distance telephone system of the Minnesota House of Representatives and Minnesota Senate in March 1993. The investigation was intended to determine whether there were unauthorized calls made on the House or Senate telephone systems that had been paid with public funds.

(16) The investigation revealed, through a computer analysis of telephone numbers that frequently charged calls to the Senate, that Paula Solon had made numerous calls from her home telephone number that were charged to the Senate.

(17) On December 5, 1995, before the Honorable Kenneth J. Fitzpatrick, Judge of Ramsey County District Court, Senator Solon pleaded guilty to a violation of Minnesota Statutes, section 609.893, subdivision 1, Telecommunications and Information Services Fraud, a misdemeanor, and Minnesota Statutes, section 609.05, Liability for Crimes of Another and brought upon the Senate dishonor and disrepute.

(18) Senator Solon was fined \$500 and sentenced to 90 days in jail. The jail sentence was suspended on the following conditions:

(a) That he remain law-abiding for a period of one year.

(b) That he pay the fine within one year.

(c) That he make complete restitution to the Senate within one year for all calls charged to the Senate that were not for Senate business.

(19) On December 12, 1995, Senator Solon relinquished his duties as Chair of the Committee on Commerce and Consumer Protection, pending resolution of the proceedings of the Subcommittee on Ethical Conduct.

NOW, THEREFORE,

BE IT RESOLVED, by the Senate of the State of Minnesota:

(1) That the conduct of Senator Sam G. Solon, in providing the Senate's long-distance telephone access code to his ex-wife, who made calls that were not on Senate business, was criminal.

(2) That Senator Sam G. Solon's decision voluntarily to resign as chair of the Committee on Commerce and Consumer Protection was an appropriate disciplinary action that should continue for the remainder of his term.

(3) That Senator Sam G. Solon be removed from membership on the Committee on Rules and Administration for the remainder of his term.

(4) That Senator Sam G. Solon make restitution to the Senate for the cost of calls made by his ex-wife and not reimbursed to the Senate by her.

(5) That Senator Sam G. Solon be required to apologize to the Senate in open session.

(6) That the reprimand of Sam G. Solon on Thursday, March 24, 1994, be reaffirmed.

Mr. Neuville moved to amend Senate Resolution No. 89 as follows:

Page 3, after line 18, insert:

"(20) Senator Solon's punishment to date has been the result of his criminal conduct, not the result of his unethical conduct.

(21) Senator Solon's criminal punishment does not adequately restore the dignity and reputation of the Senate. Only action by the Senate can purge the stain on the Senate's reputation and integrity.

(22) Senator Solon was not candid and forthright in:

(a) April 1993, when he reimbursed the Senate approximately \$3,000 for Mr. Westin and did not recall that Paula Solon had been using the Senate's long-distance telephone service.

(b) May 1993, when he apologized to the Senate without referring to Paula Solon.

(c) The period through March 1994, when he failed to tell the Secretary of the Senate about Paula Solon's telephone usage.

(d) Failing to disclose Paula Solon's telephone usage to the Ramsey County Attorney when amnesty was offered."

Page 4, after line 1, insert:

"(7) That Senator Sam G. Solon be asked to resign his office as a Minnesota State Senator effective May 1, 1996.

(8) If Senator Solon refuses to resign, his Senate salary and benefits, including insurance coverage, expense reimbursements, and pension benefits, should be terminated as of that date for the balance of 1996.

(9) That Senator Solon lose all seniority and that he not be allowed to serve as chair or vice-chair of any legislative committee or commission."

Mr. Neuville moved to amend the Neuville amendment to Senate Resolution No. 89 as follows:

Page 1, delete lines 11 to 20

The motion prevailed. So the amendment to the amendment was adopted.

The question was taken on the adoption of the amendment, as amended.
