WRIT OF SPECIAL ELECTION TO FILL
VACANCY IN THE OFFICE OF REPRESENTATIVE
OF THE 63RD DISTRICT IN THE COUNTY OF
ST. LOUIS, THE STATE OF MINNESOTA AND
OF SPECIAL PRIMARY ELECTION TO NOMINATE
CANDIDATES FOR SAID OFFICE

To the People of the State of Minnesota, and particularly
of the 63rd Legislative District in the County of
St. Louis; to the Secretary of State of the State of
Minnesota; to the County Auditor of the County of St.
Louis; to all Election Officials of said 63rd District
and of the several Election Districts therein; and to
all Others Whome it may Concern - GREETINGS:

WHEREAS, the House of Representatives has certified
that Barney Bischoff was not legally elected and is not
eligible to retain his seat as a Representative of the 63rd
Legislative District in the County of St. Louis in the State
House of Representatives and that a vacancy therefore exists
in the office of Representative of the 63rd Legislative
District; and

WHEREAS the State Legislature is now in session
and the person elected to fill said vacancy will have occasion
to take office and exercise the functions thereof immediately
after his election;


NOW, THEREFORE, I, HAROLD LeVANDER, AS GOVERNOR OF
THE STATE OF MINNESOTA, acting under the authority and
direction of Minnesota Constitution Art. IV Sec. 17 and
Minnesota Statutes 1967 Sec. 203.45 and other relevant statutes
do hereby direct:

- (1) that a special election to fill the
vacancy be held in the 63rd Legislative
District on Tuesday, the 11th of March,
1969;




- (2) that a special primary election for the nomination of candidates for the office be there held on Tuesday, the 25th day of February, 1969;
- (3) that affidavits of candidacy must be duly filed on or before Tuesday, the 18th day of February, 1969;
- (4) that the notices of this special election and special primary election, the nomination and election of candidates, and the conduct of these elections be had and all things pertaining thereto be done as provided by Minn. Stat. 1967 Sections 203.44 to 203.55 and other applicable provisions of law.
- (5) that this Executive Order supersede Executive Order No. 33.

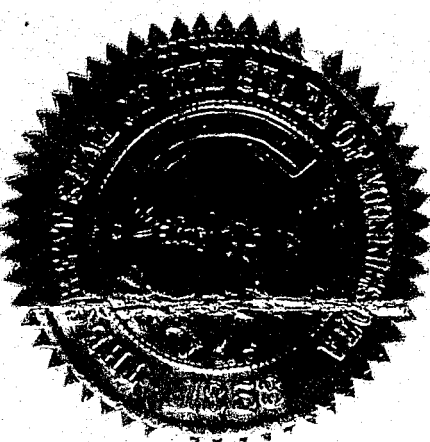
