NOW, THEREFORE, I, HAROLD LeVANDER, AS GOVERNOR OF THE STATE OF MINNESOTA, acting under the authority and direction of Minnesota Constitution Art. IV Sec. 17 and Minnesota Statutes 1967 Sec. 203.45 and other relevant statutes do hereby direct:

(1) that a special election to fill the vacancy be held in the 63rd Legislative District on Tuesday, the 11th of March,

- (2) that a special primary election for the nomination of candidates for the office be there held on Tuesday, the 25th day of February, 1969;
- (3) that affidavits of candidacy must be duly filed on or before Tuesday, the 18th day of February, 1969;
- (4) that the notices of this special election and special primary election, the nomination and election of candidates, and the conduct of these elections be had and all things pertaining thereto be done as provided by Minn. Stat. 1967 Sections 203.44 to 203.55 and other applicable provisions of law.
- (5) that this Executive Order supersede Executive Order No. 33.

- (4)that the notices of this special election and special primary election, the nomination and election of candidates, and the conduct of these elections be had and all things pertaining thereto be done as provided by Minn. Stat. 1967 Sections 203.44 to 203.55 and other applicable provisions of law.
