WRIT OF SPECIAL ELECTION

WRIT OF SPECIAL ELECTION TO FILL A CERTAIN VACANCY IN THE OFFICE OF STATE REPRESENTATIVE OF HOUSE DISTRICT 15A IN THE COUNTY OF KANDIYOHI, STATE OF MINNESOTA, AND OF A SPECIAL PRIMARY TO NOMINATE THE CANDIDATES FOR THE SPECIAL ELECTION.

To the People of the State of Minnesota, and particularly of House District 15A in the County of Kandiyohi; to the Secretary of the State of Minnesota; to the auditor of the above-named county; to all election officials in House District 15A and to all others who may be concerned:

WHEREAS, a vacancy has occurred in the office of State Representative from House District 15A of the State of Minnesota, caused by the resignation, effective January 4, 1994, of Representative Alan Welle; and

WHEREAS, a special election to fill said vacancy is necessary to assure representation for the citizens of House District 15A:

NOW, THEREFORE, I, Arne H. Carlson, as Governor of the State of Minnesota, acting under the authority and direction vested in me by the Minnesota Constitution, Article IV, Section 4, and Minnesota Statutes Sections 204D.17 to 204D.27, and other relevant statutes, do hereby direct that:

1. A special election to fill said vacancy be held in House District 15A on Tuesday, February 8, 1994.
2. A special primary, if necessary, for the nomination of candidates for the office be held in House District 15A on Tuesday, January 25, 1994.




