WRIT OF SPECIAL ELECTION

**WRIT OF SPECIAL ELECTION TO FILL A CERTAIN VACANCY IN THE
OFFICE OF STATE REPRESENTATIVE OF HOUSE DISTRICT 49B IN THE
COUNTY OF ANOKA, STATE OF MINNESOTA, AND OF A SPECIAL
PRIMARY TO NOMINATE THE CANDIDATES FOR THE SPECIAL
ELECTION.**

To the People of the State of Minnesota, and particularly of House District 49B in the County of Anoka; to the Secretary of the State of Minnesota; to the auditor of the above-named county; to all election officials in House District 49B and to all others who may be concerned:

WHEREAS, a vacancy has occurred in the office of State Representative from House District 49B of the State of Minnesota, caused by the resignation, effective March 5, 1995, of Representative Joel Jacobs; and

WHEREAS, a special election to fill said vacancy is necessary to assure representation for the citizens of House District 49B:


NOW, THEREFORE, I, Arne H. Carlson, as Governor of the State of Minnesota, acting under the authority and direction vested in me by the Minnesota Constitution, Article IV, Section 4, and Minnesota Statutes Sections 204D.17 to 204D.27, 351.01, 351.055, and other relevant statutes, do hereby direct that:

1. A special election to fill said vacancy be held in House District 49B on Tuesday, April 4, 1995.
2. A special primary, if necessary, for the nomination of candidates for the office be held in House District 49B on Tuesday, March 21, 1995.




3. Affidavits and petitions of candidacy be filed with the Anoka County Auditor from Tuesday, March 7, 1995, until 5:00 p.m. on Tuesday, March 14, 1995.
4. Notices of this special election and special primary be given, that the nomination and election of candidates be conducted and that all things pertaining thereto be done as provided by Minnesota Statutes, Sections 204D.17 to 204D.27, and other applicable provisions of law.
