GOVERNOR'S ORDER NO. 9 FOR 1934

ORDER PROVIDING ADDITIONAL PROTECTION FOR
CHINESE RINGNECK OR ENGLISH PHEASANTS:

Whereas, the Director of the Division of Game and Fish of the Minnesota Department of Conservation has investigated the necessity of providing additional protection for Chinese Ringneck or English pheasants and has found that these species are in danger of undue depletion,

Therefore, I, Floyd B. Olson, Governor of the State of Minnesota, pursuant to authority vested in me by Mason's Minnesota Statutes of 1927, Section 5640, do hereby order and declare that Chinese Ringneck or English pheasants for which an open season has been declared may be taken for a period of nine half days during the year 1934 on the following dates only: October 20, 21, 22, 23, 24, 25, 26, 27, and 28. Shooting hours to be from twelve o'clock noon to sunset each day. The counties in this state wherein such Chinese Ringneck or English pheasants may be taken in accordance herewith, are as follows:

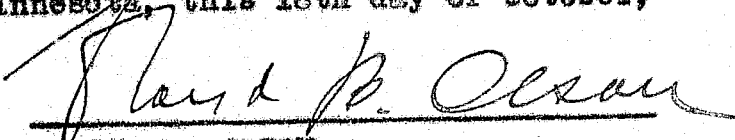
Houston, Fillmore, Mower, Winona, Olmsted, Dodge, Wabasha, Norman, Clay, Wilkin, Freeborn, Faribault, Martin, Jackson, Nobles, Rock, Pipestone, Murray, Cottonwood, Watonwan, Blue Earth, Waseca, Steele, Goodhue, Rice, LeSueur, Nicollet, Brown, Redwood, Lyon, Lincoln, Yellow Medicine, Renville, Sibley, Scott, Dakota, Washington, Hennepin, Carver, McLeod, Wright, Necker, Kandiyohi, Chippewa, Lac qui Parle, Big Stone, Swift, Traverse, Stevens, Pope, Stearns, Sherburne, Anoka, Chicago, Isanti, Pine, Kanabec, Mille Lacs, Benton, Morrison, Todd, Douglas, Grant, Ottertail, Wadena, Crow Wing, Aitkin, Carlton, Cass, Hubbard and Becker.

I do further order that a person may take in one day during the open season not to exceed three Chinese Ringneck or English pheasants, all of which shall be cocks, and shall not take or have in possession to exceed six Chinese Ringneck or English pheasants in the aggregate at any one time, and shall not take to exceed eighteen such pheasants in the aggregate for the season.

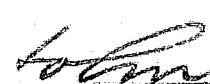
This regulation or order supersedes the order of the Director of the Division of Game and Fish of the State of Minnesota, relative to the season and regulations for the taking of such pheasants, made and issued on the 29th day of August, 1934, and known and designated as Director's Order #596, which order is hereby declared to be null and void.

This regulation and order is made by me so as to properly protect such Chinese Ringneck or English pheasants and to prevent the undue depletion thereof.
