WRIT OF SPECIAL ELECTION TO FILL VACANCY IN THE OFFICE OF STATE REPRESENTATIVE OF DISTRICT 66A ENCOMPASSING THE COUNTY OF NORMAN AND PART OF THE COUNTY OF POLK, STATE OF MINNESOTA AND OF SPECIAL PRIMARY ELECTION TO NOMINATE CANDIDATES FOR SAID OFFICE.


To the People of the State of Minnesota, and particularly of Legislative District 66A encompassing the county of Norman and part of the county of Polk; to the Secretary of State of the State of Minnesota; to the County Auditors of the Counties of Norman and Polk; to all Election Officials of said District 66A and of the several Election Districts therein; and to All Others Whom it may Concern - GREETINGS:

WHEREAS a vacancy now exists in the office of State Representative from Legislative District 66A of the State of Minnesota, caused by the death of the late State Representative, the Honorable Marvin E. Christianson, and

WHEREAS the State Legislature is now in session and the person elected to fill said vacancy will have occasion to take office and exercise the functions thereof immediately after his election;

NOW, THEREFORE, I, HAROLD LEVANDER, AS GOVERNOR OF THE STATE OF MINNESOTA, acting under the authority and direction of Minnesota Constitution Art. IV Sec. 17 and Minnesota Statutes 1967 Sec. 203.45 and other relevant statutes do hereby direct:

> that a special election to fill the vacancy be held in Legislative District
> 66A on Tuesday, the 8th day of April, 1969;



- (2) that a special primary election for the nomination of candidates for the office be there held on Tuesday, the 25th day of March, 1969;
- (3) that affidavits of candidacy must be duly filed on or before Tuesday, the 18th day of March, 1969;
- (4) that the notices of this special election and special primary election, the nomination and election of candidates, and the conduct of these elections be had and all things pertaining thereto be done as provided by Minn. Stat. 1967 Sections 203.44 to 203.55 and other applicable provisions of law.

IN WITNESS WHEREOF, I have hereunto caused the Great Seal of the State to be affixed and have hereunto set my hand at the Capitol, in the City of St. Paul, Minnesota this 11th day of March, 1969.
