WRIT OF SPECIAL ELECTION TO FILL VACANCY  
IN THE OFFICE OF STATE REPRESENTATIVE OF  
DISTRICT 61A WITHIN THE COUNTY OF HENNEPIN,  
STATE OF MINNESOTA AND OF SPECIAL PRIMARY  
ELECTION TO NOMINATE CANDIDATES FOR SAID  
OFFICE.

To the People of the State of Minnesota and  
particularly of the Legislative District 61A,  
within the County of Hennepin; to the Secretary  
of the State of Minnesota; to the County Auditor  
of the County of Hennepin; to the City Clerk of the  
City of Minneapolis; to all Election Officials of  
said District 61A; and to all others who may be  
concerned - Greetings:

WHEREAS, a vacancy now exists in the office of  
State Representative from District 61A of the State of  
Minnesota, caused by the resignation of the Representative,  
the Honorable Gary W. Flakne, and

WHEREAS, primary and general elections will be held  
in the City of Minneapolis at such times that a  
contemporaneous special election to fill said vacancy  
will permit the person elected to take office at the  
opening of the next session of the legislature,

NOW, THEREFORE, I, WENDELL R. ANDERSON, AS  
GOVERNOR OF THE STATE OF MINNESOTA, acting under the  
authority and direction of Minnesota Constitution  
Art. IV Sec. 17 and Minnesota Statutes Sec. 203.44 to  
203.55 and other relevant statutes do hereby direct:

- (1) that a special election to fill the  
vacancy be held in Legislative District  
61A on Tuesday, the 6th day of November,  
1973;
- (2) that a special primary election for the  
nomination of candidates for the office  
be there held on Tuesday, the 25th day  
of September, 1973;
- (3) that affidavits of candidacy must be duly  
filed on or before Thursday, the 23rd day  
of August, 1973;
- (4) that the notices of this special election  
and special primary election be given, that  
the nomination and election of candidates  
and the conduct of these elections be had  
and all things pertaining thereto be done  
as provided by Minn. Stat. 1971 Sections  
203.44 to 203.55 and other applicable  
provisions of law.

IN WITNESS WHEREOF, I have hereunto caused the  
Great Seal of the State to be affixed and have  
hereunto set my hand at the Capitol, in the  
City of St. Paul, Minnesota this 24<sup>th</sup> day of  
July, 1973.
