

EXECUTIVE ORDER NO. 122

Repealing certain Executive Orders

I, Wendell R. Anderson, by virtue of the authority vested in me by the Constitution and applicable Statutes, hereby issue this Executive Order:

- All Executive Orders issued before January 1, 1971 to be repealed;
