GOVERNOR PAWLENTY NAMES ALICE SEAGREN COMMISSIONER OF EDUCATION

Saint Paul – Governor Tim Pawlenty today named State Representative Alice Seagren as the new commissioner of the Minnesota Department of Education. Seagren, currently the Chair of the Minnesota House of Representatives Committee on Education Finance, has served as a legislator since 1992. 



I am writing to add my voice to the many I am sure you have heard in recent days encouraging you and your colleagues to confirm Alice Seagren as Commissioner of Education. In over 35 years of work in public education, I have encountered few public officials who care as much about schools and understand them as well as Commissioner Seagren does. If I had to capture in a few words the reasons that I believe she is the right leader for our state education agency at this point in time, I would offer the following:

Principled: As you know, Commissioner Seagren's involvement in school improvement and reform began as a concerned parent, and it remains rooted in a commitment to improving the educational experiences of every Minnesota student. That commitment enables her to bring people together across partisan, ideological and organizational lines to do what is right for kids.

Smart: Although Commissioner Seagren is not an educator herself, she has a deep understanding of the critical issues facing Minnesota's schools today. Whether the issue is school funding, No Child Left Behind or value added assessment, she studies and masters the details without losing the big picture.

Collaborative: During her first months as Commissioner of Education, Commissioner Seagren has reached out to members of our diverse educational community in Saint Paul, asking for their ideas on the future of public education in our city and our state. Although Commissioner Seagren is not afraid to make a tough decision that will produce disagreement, her first impulse is to bring people together to forge and implement a shared vision. 


