Senator Hottinger called the meeting to order at 3:10 p.m.

AGENDA ITEM #1: **S.F. 3296-Hottinger:** NorthStar Quality Improvement and Rating System Senator Hottinger gave a summary of the QRS bill.

- Todd Otis, President, Ready 4K, talked about the importance of empowering parents. A quorum was present.
 - Nancy Johnson, Director of Public Policy, Greater Minneapolis Day Care Association, ran the committee through her QRS PowerPoint.
 - Ann McCully, Executive Director, MN Child Care Resource and Referral Agency, spoke to how QRS is good for parental support.
 - Dr. Kathryn Tout, Director, Applied Research in Early Care & Education, Child Trends, helped construct the QRS, and she explained the implementation process.
 - Dr. Prof. Scott McConnell, Director of CEED, University of Minnesota, talked about how assessment and enhancement of quality is essential. He urged the committee to think about the needs of children.
 - Byron Laher, Director of Public Policy, Greater Twin Cities United Way, is proud to report that 85% of their graduates are ready to learn by kindergarten. He is hoping to continue this accomplishment.
 - Julie Quist, Ed Watch, stands opposed to the QRS. She claims this is 'diversity training' for the young.
 - Dr. Prof. Scott McConnell talked about NAEYC (National Association for the Education of Young Children).
 - Barbara O'Sullivan, ELS Supervisor, Minnesota Department of Education, mentioned that the contentious book has been taken out of the reference list.

MOTION: Senator Hottinger moved the A-1 Amendment.

Passed.

MOTION: Senator Hottinger moved the bill to be included in the Committee recommendations. Passed.

AGENDA ITEM #2: **S.F. 906-Bonoff:** Kindergarten Assessment Initiative.

Senator Bonoff gave a summary of the bill. This bill helps to identify children who need help, and it targets the neediest children first.

MOTION: Senator Scheid moved the A-3 Amendment

- Zoe Nicholie, Public Policy Director, Ready 4K, supports voluntary availability of the initiative.
- Claudia Otos and Lori Fichtner, Proctor-Hermantown Early Childhood Coalition, spoke to how assessment is important for all communities, regardless of their circumstances. Ms. Fitchtner, talked about the strategies used to education their young children.
- Julie Quist, Ed Watch, opposes the bill, because it is based on the 'subjective' indicators of progress.

MOTION: Senator Pappas moved to include the bill in the Committee recommendations. Passed.

AGENDA ITEM #3: S.F. 3295-Bonoff: Increasing ECFE Funding.

Senator Bonoff gave a summary of the bill.

MOTION: Senator Kubly moved the A-1 Amendment.

Passed.

- Marcia Treno, Wayzata ECFE, spoke to how the suburbs need ECFE as well.
- Karen Burkhartzmeyer, parent, supports this bill. ECFE has been invaluable to her.
- Dubee Kuruz, Hopkins ECFE, credits ECFE for his parenting skills.
- Jane Roundtree, Program Supervisor, Anoka-Hennepin Early Childhood Special Education, wants more funding so she can expand her program.
- Ms. Maskuga, parent, supports the bill because it is good for special needs children. ECFE has helped her son, Tyler.

MOTION: Senator Scheid moved to include the bill in the Committee recommendations. Passed.

AGENDA ITEM #4: **S.F. 3280-Rosen:** Removing ECFE teachers from definition of public employee.

Senator Rosen introduced the bill.

- Dar Holmseth, Blue Earth Area ECFE, explained how the ECFE ruling has negatively impacted her.
- Sue Harris, St. James Area ECFE, is supportive of the bill. She spoke about her tight budgets, and how they need all the money they can get.
- Christina Clark, attorney for Education Minnesota, supports unions. She explained how it would be bad public policy to pass this bill.
- Jackie Mosqueda, Osseo Public Schools, shared her concerns about the bill. She does not want her union rights to be taken away.
- Ada Alden, Eden Prairie Public Schools, Director of Family Education, talked about the importance of the voice of the union, and the voice of licensed ECFE teachers.
- Brian Burgson, MAPE, spoke against the bill. His concern is a negative precedent.
- Jan Alswager, Education Minnesota, answered questions from the Committee. She spoke to how ECFE teachers are not paid enough. The problem is with PELRA, and not with union fees.

MOTION: Senator Wergin moved to lay the bill on the table.
