Senator Kubly called the meeting to order at 3:10 p.m.

AGENDA ITEM #1: **S.F. 3384-Pogemiller:** Establishing an allowance for early childhood learning preparedness and enrichment expenses.

Senator Pogemiller walked the Committee through the bill. He explained, "Let's get real, let's do something." This allowance is not meant for childcare, it is meant to enhance education. Senator Pogemiller explained how \$300 million would be raised via a 4th tier tax bracket.

A quorum was present.

MOTION: Senator Scheid moved to re-refer S.F. 3384 to Finance. Passed.

AGENDA ITEM #2: **S.F. 2883-Sparks:** Child care licensing provisions modification. Senator Sparks introduced the bill.

• Kathy Stutzman, Financial Director, Parenting Resource Center, Austin, MN, explained the importance of quality sleeping facilities.

MOTION: Senator Sparks moved to re-refer S.F. 2883 to Finance.

AGENDA ITEM #3: **S.F. 2997-Hottinger**: Child care reimbursement rate additional category and absent days.

- Ann Kaner-Roth, Child Care WORKS, explained how this proposal came from a health and safety discussion that happened last year. Ms. Kaner-Roth supports the bill.
- Beth Mork, Minnesota Licensed Family Child Care Association, spoke to the positive

- impact of quality training for educators.
- Brigid Riley, Executive Director, Minnesota Organization on Adolescent Pregnancy, Prevention & Parenting, talked about the deleted third section. She is supportive of the bill
- Karen Cadigan, Research Associate, University of Minnesota, spoke to the additional training requirements. Ms. Cadigan explained that better trained people equals better outcomes for children.
- Joan White, Senate Counsel and Research, explained the oral amendments.
- Cherie Kotilinek, Manager, Child Care Assistance Program, explained the pre-2005 changes in the absent day section.

MOTION: Senator Scheid moved to repeal Section 119B.13, Subd. 7. (This motion was made under the assumption that this issue would be revisited.

Passed.

MOTION: Senator Kierlin moved to strike Section 6 from the adopted A-3 Amendment. Passed.

MOTION: Senator Scheid moved to lay the bill over for possible inclusion in the omnibus bill. Passed.

AGENDA ITEM #4: **S.F. 3615-Hottinger**: Third party co-pay modification.

Senator Hottinger and Eric Haugee, Committee Administrator, explained the bill.
