

SUSPENSE FILE PROGRESS

When a record is in "suspense," it means that a court disposition cannot be linked to criminal history records via fingerprints. The BCA-CJIS Suspense Team was charged by the legislature with reducing the number of criminal history records in suspense.

Background

When records are in suspense, a number of significant consequences may result:

- Individuals with multiple convictions may appear as first-time offenders.
- Handguns may be sold to people not eligible to purchase them.
- People subject to predatory offender registration may avoid monitoring.
- Weapons may be sold to people convicted of domestic assault.
- Applicants may erroneously be allowed or denied employment or housing.
- Charging, plea agreement, sentencing, placement, and treatment decisions are made on incomplete information

In 2001, the legislature allocated money for the CriMNet program, which included funds to dedicate staff at the BCA to reducing suspense files.

- In June 2001, there were 450,000 criminal history records in suspense.
- In 2001, suspense files became searchable by all criminal justice professionals.
- Electronic exchange of dispositions between courts and the BCA has alleviated suspense files.
- Records submitted to the BCA continue to go into suspense for a number of reasons.

Progress

The Suspense Team has made significant progress toward meeting the goals from the 2001 law.

<u>Milestone</u>	<u>Progress</u>
• Reduce historical suspense to 45,000 by July 2003	Historical suspense files reduced to 77,000.
• Reduce flow of new dispositions into suspense to 20 percent by July 2003 and 10 percent in future years	Currently, 15 percent of incoming records go into suspense.
• Assist local agencies with improving their data collection business practices.	Suspense team staff conducted 97 business practice audits in 2004.
• Provide Criminal and Juvenile Justice Information Policy Group with summary data.	Suspense staff maintain a Web site providing agency suspense statistics.
• Provide the Policy Group with information about records not entered into the state's Automated Fingerprint Identification System (AFIS).	AFIS-based backlog eliminated in 2002.
• Notify entities when a record goes into suspense.	650 law enforcement entities receive automated suspense notification.

Next Steps

- CriMNet Program to assist with managing business practices contributing to flow of dispositions into suspense status
- CriMNet-managed education effort regarding local agency fingerprint procedures
- Enhanced quality assurance efforts by BCA-CJIS
- CriMNet identification service project will strengthen agency identification procedures
- Updated BCA-CJIS automated fingerprint capture system will eliminate need to produce fingerprint cards for every arrest

TARGETED MISDEMEANORS

Criminal justice professionals make decisions about charging, releasing, sentencing, recommending treatment and programming, as well as perform critical background checks based on the information in the computerized criminal history files – making the completeness of those criminal history files critical. BCA-CJIS and CriMNet are working to automate the inclusion of targeted misdemeanors for professionals to have the necessary information to make informed decisions.

Background

In 1997, the legislature deemed seven misdemeanor-level crimes as targeted misdemeanors and required agencies to collect fingerprints from offenders and include targeted misdemeanor dispositions on the computerized criminal history.

These offenses are significant because they affect the following criminal justice decisions:

- They include enhanceable offenses.
- They affect a person's eligibility for procuring a weapon or handgun permit.

Targeted Misdemeanors

- fifth-degree assault
- domestic assault
- interference with privacy
- restraining order violation
- order for protection violation
- driving while intoxicated, and
- indecent exposure

Progress

- Dispositions are now passed electronically to the BCA so they may be more efficiently linked to fingerprints in the criminal history system
- Records in suspense are searchable, which means the information is available for background checks, weapons eligibility checks, and checks for employment and housing.
- Court dispositions for Orders for Protection include a flag to note a prohibition from possessing or receiving a firearm. Those records are forwarded to the BCA and FBI for state and national firearm sale checks.

Next Steps

- The CriMNet Policy Group has recommended changes to state law governing when and how fingerprints should be taken.
- CriMNet Program staff will develop training materials to assure records are properly flagged and agencies understand criminal history records.
- CriMNet will enhance the Minnesota Statute Table to flag targeted misdemeanors and convictions requiring predatory offender registration.
- CriMNet and the BCA will solicit federal grant funds to further improve the automation of targeted misdemeanor information to criminal history records.

The Problem

- What is Suspense? It is a court disposition that cannot be linked back to a fingerprint record taken at arrest/booking or at charging.
- Why is it important to link these records? Offenders often lie about their name and date of birth - creating many alias' to avoid responsibility for their behavior.
- Which types of offenses are involved? By statute all adult felony, gross misdemeanor, and targeted misdemeanor, as well as serious juvenile offenses should have a complete criminal history record backed by fingerprints.

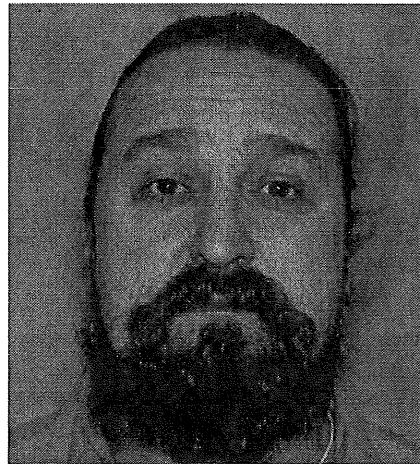

What are the Possible Consequences?

- Treat career criminals as first-time offenders
- Release people who should not be released
- Sell handguns to people who are barred from purchasing handguns
- Inappropriate charging, plea agreement, disposition, sentencing, classification, treatment, placement, and other decisions



More Examples of Possible Consequences

- Criminals avoiding Predatory Offender registration and monitoring.
- Children, vulnerable adults, and other members of the public exposed to violent or sexual predators.
- Weapons sold to persons convicted of domestic assault.
- Individuals being arrested for other person's crimes.
- Applicants being erroneously allowed or denied employment or housing.



Are these court disposition records in suspense visible?

- To criminal justice agencies? Yes, since 2001 these records are query-able.
- To the public at the BCA or over the Internet. No
- For employment related background checks?
 - Yes for the BCA when doing a statutorily mandated background check.
 - No. For Department of Human Service checks of foster care, day care licenses, etc.
- For license and gun purchases? Yes. The BCA resolves records in suspense and reports convictions that disqualify the applicant.

Suspense Project Goals

Minn. Laws 2001*, and M.S. 299c.10, 299c.111

- Reduce the 450,000 **adult felony and gross misdemeanor records** then in the "tub" to 45,000
- Reduce the "flow" from 50% going into suspense to 10% into the future
- Provide summary data on suspense to justice agencies and the Policy Group
- Provide Policy Group with number of identification records not entered on the AFIS and Criminal History System
- Immediately notify appropriate entity when record goes into suspense

Suspense Project Accomplishments

- "Tub" reduced to 77,020
- "Flow" to just over 10% then added traffic DUI. Currently 14% with traffic
- Web site provides updated monthly statistics to agencies and Policy Group
- All identification records immediately added to AFIS and Criminal History System - no backlog since June 2002
- 650 law enforcement agencies notified immediately when record goes into suspense (Apr 2004)



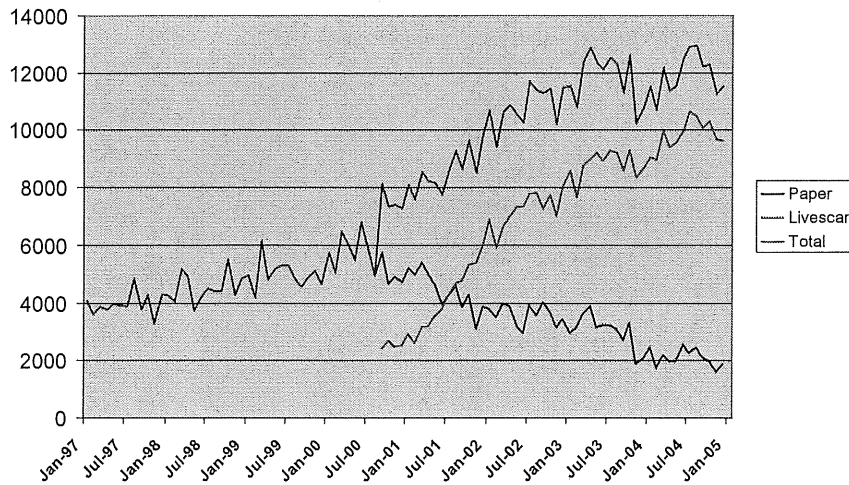
AFIS Statistics

- Over 11,000 fingerprints are received each month (paper and electronic).
- Over 9,500 fingerprints are received electronically each month from over 150 Livescans.
- In 2004, over 82% of fingerprints were received electronically, compared to 74% in 2003.
- In 2004, over 143,000 fingerprints were received.
- The current MAFIN AFIS contains over 1.3 million sets of fingerprints in (90% of current capacity).

Remaining Challenges

- Remaining "flow" of 10 to 14% adds to "tub". 37,534 new suspense records need to be resolved.
- Juvenile offenses that would be felonies if committed by an adult - 43,361 cases in suspense
- Targeted Misdemeanors records in and going into suspense - approximately 47,000 today (more on this later in the presentation)

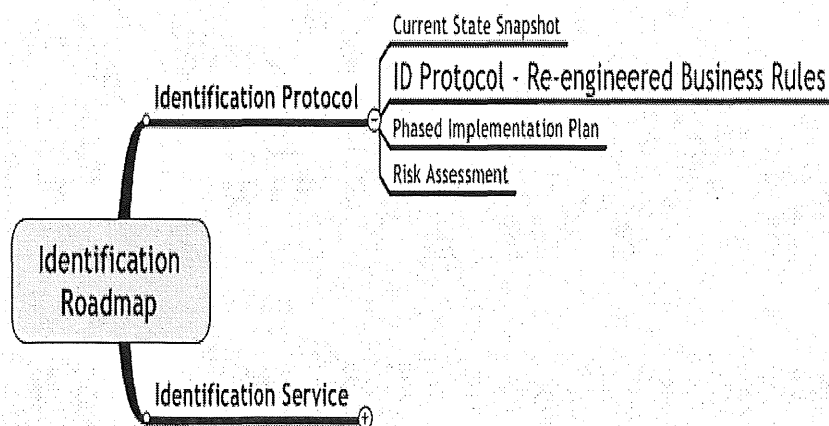

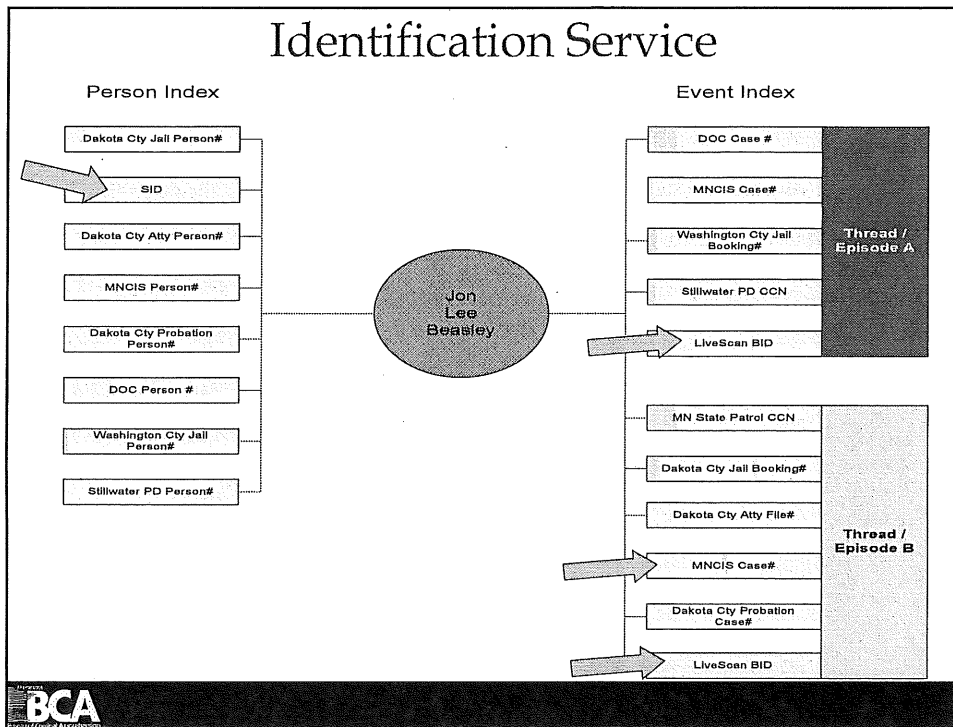
- Business Practice Issues to be managed by CriMNet Program (“flow”)
- Educating justice agencies on importance of capturing fingerprints and linking numbers to be managed by CriMNet Program
- Quality Assurance (“tub”) managed by CJIS
- CJIS will do background checks for DHS where there are suspense records and resolve suspense - or recommend a policy change

AFIS Upgrade Features

- Re-engineer identification process
 - Currently rolled 10 prints required on every arrest/charge
 - Only one set of rolled 10 prints (plus palm prints) needed for latent processing
 - Add an identification capability
 - Expensive capture devices (Livescan) hence limited use for identification purposes
 - More identification points in the justice process

AFIS Upgrade Plan

- Re-engineer criminal record capture process
 - Rolled 10-prints once (for latent match)
 - Quickly check identity using 2-print technology
 - Only if no-match found collect the rolled 10-print



AFIS Upgrade Features

- Several new features will be added:
 - Palm print capture for latent searching to solve more crimes (40% of latent prints left at crime scenes are palm prints)
 - "Lights Out" processing of most fingerprints (minimal human intervention)
 - Identification process for local agencies will take minutes instead of hours - determine the identity and criminal record before leaving the booking facility.
 - More officer-time on the streets.

The Problem

- Recent report entitled "Slipping Through the Cracks: How Incomplete Data Collection Allows Domestic Abusers Access to Firearms", December 2004 concluded that 70% of persons convicted of misdemeanor assault could potentially purchase a handgun or obtain a permit to carry a weapon in MN.



Basis for the Conclusion: Targeted Misdemeanor Issue

- A study of one year's data indicated that 70% of Targeted Misdemeanors were not on file with the BCA Criminal History System.
- Targeted Misdemeanors classification created in 1997 and includes:
 - Domestic Assault
 - Violation of Harassment or Restraining Order
 - 5th Degree Assault
 - Order for Protection Violation
 - Driving While Impaired
 - Indecent Exposure



The Problem Continued

- Missing convictions could affect:
 - enhancement from misdemeanor to gross misdemeanor or felony M.S.609.224 and , and
 - affect ability to limit access to weapons M.S.609.2242



Actions Taken on Targeted Misdemeanors

- Collaboration of CriMNet, BCA-CJIS and Courts to electronically pass Targeted Misdemeanor dispositions to the BCA Criminal History System
- As of 2/4/2005 all Targeted Misdemeanor dispositions after April 2002 have been passed to BCA
- As of 2/7/2005 forward all new dispositions are being passed to BCA
- Pre 2002 dispositions will be passed as courts are converted to MNCIS
- By BCA estimates 58% going into suspense or other errors



Additional Protections to Prevent Sale of Guns to Convicted Abusers

- Background Check process - (Local) When a background check for gun purchase is requested, Local Law Enforcement would have access to suspense records that could be a disqualifier for gun purchase.
- Order for Protection Process - "Brady flag" (prohibition from possessing or receiving a firearm or ammunition) is set, depending on circumstances, on the OFP database and forwarded to BCA and FBI for NICS (national instant check for firearm sale) checks

 - The language recommended by the Policy Group will facilitate getting fingerprints
 - Program staff will educate courts and prosecution on the new provision
 - Program staff will educate law enforcement of the importance of getting the fingerprints on all offenses
- Program staff will investigate policy and business practices on Orders for Protection to insure setting the "Brady" flag
- Program staff will educate justice agencies of the availability of Targeted Misdemeanors records on CCH
- The MN Statute Table will be enhanced to flag Targeted Misdemeanors (and registerable predatory offender) statutes
- Program will seek FY 2006 NCHIP grant funds available for specifically targeting improving the automation of data relevant to restraining/protection orders and /or domestic violence misdemeanor convictions

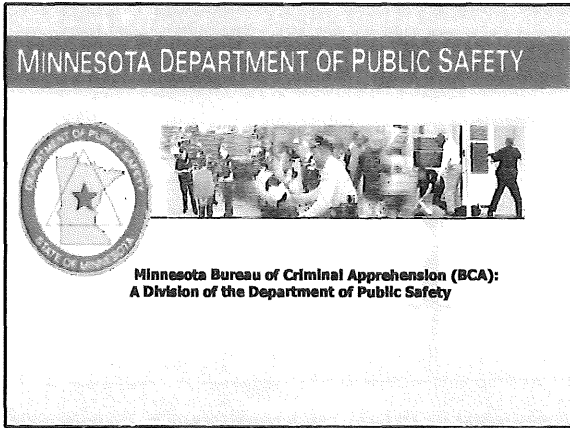

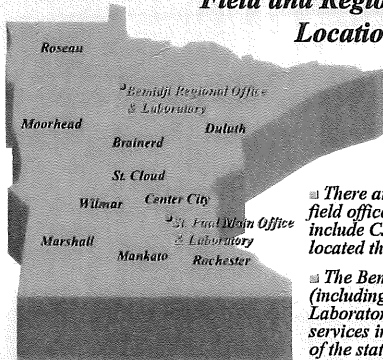

BCA Profile

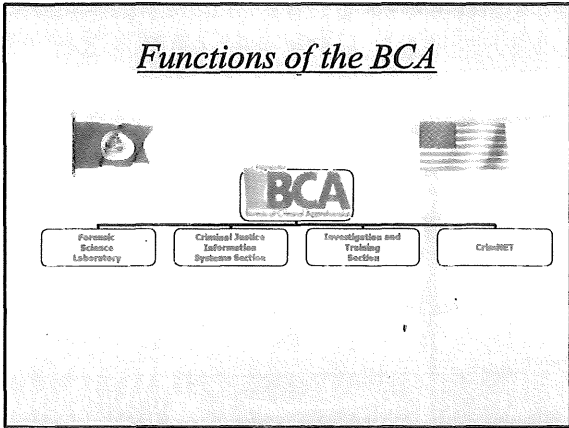

Field and Regional Office Locations

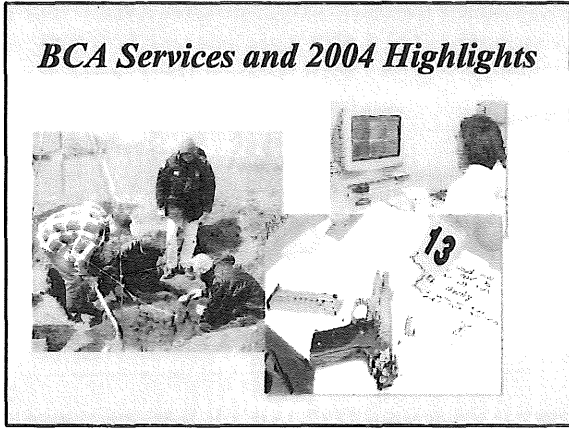


- There are 11 investigative field offices (two of which include CJIS staff) that are located throughout the state.
- The Bemidji Regional Office (including CJIS staff) and Laboratory coordinates services in the Northern part of the state.

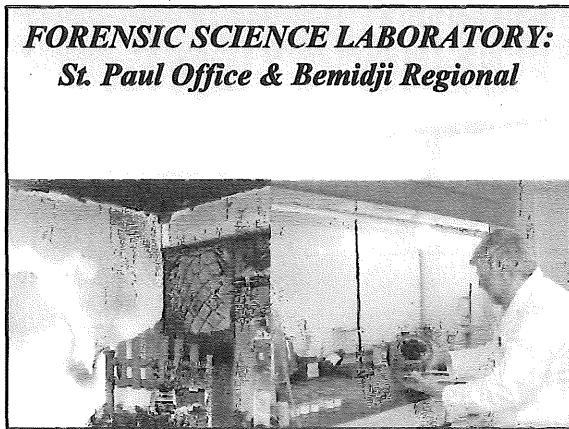

Investigations: "Meth" Investigations & POR

- 10 Agents stationed in Greater Minnesota to assist in "Meth" related investigations and associated violent crime.
- 3 agents assigned to POR to monitor, track, and conduct proactive surveillance on high risk offenders, assist local agencies with serial rapes, and other violent sex offenses, provide greater assistance to agencies in rural Minnesota.
- analyst and administrative support personnel to assist with the registration of offenders from other states/ insure all appropriate paperwork is obtained, identify high risk offenders, who are deemed most likely to re-offend, reduce processing time.

Assumption of Duty Officer Function
