# What impact does the definition of E-12 primary funding programs have, when comparing 2009 and 2010?

- if defined so that 2009 and 2010 are the same, full restoration of E-12 to the 2010 forecasted level requires restoring Higher Ed to the 2008 level, and alternatively, if Higher Ed is fully funded at the 2008 level, E-12 must be fully funded at the 2009 level, which would equal the 2010 level.
- if defined so that 2009 is less than 2010:
  - x if E-12 is fully restored to the 2009 level, then before additional funds are added to E-12, Higher Ed must also be restored to the 2008 level
  - x funding E-12 at the 2010 level uses MORE federal funds than allowed by the restoration guidelines (which only requires going to the 09 level) as a results, amounts in 2010 ABOVE 2009 must be allocated the same as Title I funding, instead of in proportion to how they were reduced.
- if defined so that 2009 is more than 2010, restoration of E-12 to forecast 2010 levels is less than 100% restoration under ARRA, (since restoration requires that funding be maintained at the 2009 level) so Higher Education funding must also be restored at an amount LESS than 100% or additional funding can be added to E-12 above the forecasted 2010 amount, up to 2009 levels. Higher education funding must also be restored proportionately if additional federal funds are added to E-12.
