Mr. Johnson moved to amend H.F. 821, the typewritten bill, as follows: Page 27, line 23, add a new section 21 as follows:

Sec. 21. Notwithstanding other provisions of Chapter 352B as amended, offective July 1, 1973, the administrative duties of the Highway Patrolmen's Fund shall be transferred and become the responsibility of the executive director and staff of the Minnesota state retirement system. The officers of the association shall furnish said executive director with all records necessary for the discharge of his assumed administrative duties. The officers of the association shall retain the same duties, powers, and authority concerning the administration of the Highway Patrol fund as the board of directors of MSRS have over that fund. The Highway Patrolmen's Fund shall pay to the MSRS, 2/10 of 1% of the payroll of its membership to defray costs of administration. The rate of pay for administration expense may subsequently be increased or decreased from time to time by agreement between the officers of the Highway Patrolmen's Association and the board of directors of MSRS.
