LEGISLATIVE COMMISSION ON PENSIONS AND RETIREMENT

MINUTES

November 6, 2013

Call to order:

Senator Sandra Pappas, Chair of the Legislative Commission on Pensions and Retirement, called the meeting to order at 1:10 p.m.

Edward Burek, Deputy Director, Legislative Commission on Pensions and Retirement, reviewed the third consideration staff memo.

Laurie Hacking, Executive Director, TRA, responded to questions from members regarding why benefit formula improvements are prospective and the effect of the various benefits on those who retire early.

Dennis Hoelscher, PERA-P&F retiree, provided handout materials and testified that retirees are paying their share of the funding burden and urged the commission to consider all proposals coming forward.

Alternative retirement plan design, first consideration.

Lawrence A. Martin, Executive Director, Legislative Commission on Pensions and Retirement, reviewed the first consideration staff memo on the topic.

David Bergstrom, Executive Director, MSRS, Mary Most Vanek, Executive Director, PERA, and Laurie Hacking, Executive Director, TRA, provided and reviewed handout materials on the 2011 Retirement Plan Design Study Report and responded to questions from members.

Mr. Burek continued his review of the third consideration staff memo.

John Fisher, President, Retired Educators Association of Minnesota (REAM), and Curt Hutchens, Past President, REAM, testified that the 2010 and 2013 pension reforms improve Minnesota plans' funding and provided handouts on Minnesota public employee pensions and on TRA employer contributions.

Non-Agenda Item**Statewide retirement plan administrators request for Actuarial Standards amendment relating to the recognition of future post-retirement adjustments – continued**

Mr. Martin distributed and reviewed the staff memo summarizing the current actuarial reporting law and Standards For Actuarial Work, the fund directors' request, and the options available to the Commission.

Mary Most Vanek, Executive Director, PERA, testified that the PERA actuary reviewed the memo and recommended a combination of Options 2 and 3, and requested that the actuaries work with staff.

Kim Crockett, COO, EVP and General Counsel, Minnesota Free Market Institute at Center of the American Experiment, testified on the topic and provided six handouts.

Mr. Bergstrom, MSRS, and Bonnie Wurst, Gabriel Roeder Smith & Co., responded to criticism of the Mercer findings in the 2011 Retirement Plan Design Study contained in one of Ms. Crockett's handouts.

Mr. Martin responded to members' questions regarding early retirement incentives and the historical funding levels of consolidating retirement plans.

Brian Rice, representing the Minnesota Professional Fire Fighters and the Minnesota Police and Peace Officers Association, testified to remind members when discussing defined benefit vs. defined contribution retirement coverage, that police officers and firefighters are not covered by Social Security.

Morgan Fleming testified on behalf of the Middle Management Association annuitants.
