RE: Information Provided by the Ethics Committee

I have received requests, from both parties to this ethics complaint, for information, only some of which is in the Ethics Committee's possession. While I do not doubt that such information would be useful to those involved, the Ethics Committee has no authority to compel the parties involved, to provide information in advance to the committee or the other party. The Ethics Committee is however, required by "Rules and Procedures for the Ethics Committee," to make public, the existence and substance of a complaint and supporting materials. No where in our committee rules or in House rules, is the committee empowered to require parties to provide advanced evidence. I have recently received some materials, provided voluntarily. Staff is currently working to duplicate the volumes received thus far, and I will forward these to you Friday.
