during the 1998-1999 school year. In the final incident that occurred last year, during the 1998-1999 school year, the juvenile female told Investigator Sommer that James Ivar Rostberg, put
his hand up her shirt, then inside of her bra where he touched her on her breasts. The juvenile female stated that she confronted about what had happened

 by Investigators Bredsten and Sommer of these several juveniles.
In a statement with a juvenile male, Investigator Bredsten learned that the juvenile female told this juvenile male , approximately two months ago, that she had been sexually touched and that began touching her when she was approximately six years old, and touching her approximately once a year up until she was in the seventh grade.
