[629.415] PROCEEDINGS ON SUMMONS TO APPEAR. Subdivision 1. Issuance of summons to appear. A court may issue a summons in 1.6 accordance with rule 3.01 of the Rules of Criminal Procedure to notify a person charged 17 with a criminal offense of the need to appear at a certain time and place to answer the charge. 1.8 Subd. 2. Service of summons. A summons may be served in accordance with rule 3.03 1.0 of the Rules of Criminal Procedure. The court shall record the manner in which the summons 1.10 was served and, if the summons was served by mailing it to the defendant's last known 111 1.12 address, the court shall record whether the summons was returned as undeliverable. Subd. 3. Failure to appear; issuance of a sign and release warrant. (a) Unless a 1.13 prosecutor makes the showing described in subdivision 4, the court shall issue a sign and 1 14 release warrant if: 1.15 1.16 (1) the court issued a summons; (2) the defendant failed to appear at the time and place identified in the summons; 1.17 (3) the defendant had not previously failed to appear in the same case; and 1.18 (4) the defendant is charged with a misdemeanor offense other than a targeted 1.19 misdemeanor, as defined in section 299C.10, subdivision 1, or a gross misdemeanor offense 1.20 other than a violation of section 169A.20 (driving while impaired); 518B.01, subdivision 1.21

2.17	(2) because a defendant poses a risk to public safety; or
2.18	(3) because the defendant otherwise poses a danger to self or others.
2.19	Subd. 5. Sign and release warrant; law enforcement duties. (a) When a peace officer
2.20	encounters a defendant who is the subject of a sign and release warrant, the officer shall
2.21	inform the defendant of the missed court appearance and provide a new notice that includes
2.22	a time to appear.
2.23	(b) Notice of the new time to appear shall be made in writing and must include the court
2.24	file number or the warrant number. The defendant may be asked to sign a form
2.25	acknowledging receipt of the notice. A defendant may not be required to sign the
2.26	acknowledgment, but the peace officer or other employee may indicate that a notice was
2.27	given and that the defendant refused to sign.
2.28	(c) After providing the notice, the peace officer shall release the defendant at the scene.
2.29	(d) As soon as practicable after providing the notice, the peace officer shall:
2.30	(1) inactivate the warrant or direct the appropriate office or department to inactivate the

3.1	(2) submit a form or other notification that can be filed in the court's electronic filing
3.2	system that includes the court case number, updates the defendant's personal contact
3.3	information, and indicates that the defendant received notice of the new time to appear.
3.4	Subd. 6. Exception; lawful arrest. Nothing in this section prohibits a peace officer from
3.5	arresting a defendant for any lawful reason.
3.6	Subd. 7. Procedure to notify peace officers; scheduling new court dates. (a) By
3.7	January 1, 2024, the sheriff of every county, in coordination with the district court of that
3.8	county, shall develop a procedure to inform peace officers about the type of warrant issued
3.9	by the court and provide hearing dates for sign and release warrants.
3.10	(b) At a minimum, the procedure shall include:
3.11	(1) an office, department, or other entity that a peace officer can contact at any time to
3.12	determine the type of warrant issued by a court;
3.13	(2) if the warrant is a sign and release warrant, the ability to obtain an updated time for
3.14	a defendant to appear to answer the charge;
3.15	(3) the ability to inactivate a sign and release warrant after a defendant has been notified
3.16	of the new time to appear; and
3.17	(4) the ability to submit a form or other notification to the court's electronic filing system
3.18	updating the defendant's personal contact information and indicating that the defendant
3.19	received notice of the new time.
3.20	(c) The sheriff may develop forms to provide defendants with notice of the new time to
3.21	appear.
3.22	<b>EFFECTIVE DATE.</b> This section is effective July 1, 2021, and applies to warrants
3.23	issued on or after January 1, 2024
