- 1.5 Section 1. Minnesota Statutes 2022, section 383B.908, subdivision 5, is amended to read:
- 1.6 Subd. 5. **Financial oversight.** The county board shall approve, by majority vote, the
- 1.7 annual budget of the corporation and receive an annual audited financial statement. The
- 1.8 annual budget shall address how efficiencies and revenues contribute to stabilize or reduce
- 1.9 county liabilities for indigent care. The county board shall also retain the right to conduct
- 1.10 an independent audit of the finances of the corporation.
