1.3 trafficking investigations and firearm seizures by the Bureau of Criminal Apprehension and  
1.4 Violent Crime Enforcement Teams; amending the definition of trigger activator; increasing  
1.5 penalties for transferring firearms to certain persons who are ineligible to possess firearms;
